# DISTINGUISHED SERVICE AWARDS

It is time again to start thinking about recognizing someone that has made an outstanding contribution in areas of: NASCOE; FSA – Agriculture; or Community Service. This program encourages recognition of NASCOE members who make outstanding contributions in one of the three areas. Any member of the Association may make a nomination. Only members of the association who are in good standing, who are serving under a permanent appointment, or who have voluntarily retired during the current year are eligible to receive these awards. Nominations need to be mailed NO LATER than FEBRUARY 1<sup>st</sup>, 2006.

### INFORMATION FOR EACH CATEGORY

SERVICE TO NASCOE: Years of NASCOE membership; committee activity; offices held; contributions to the organization; FSA background and any other pertinent information can also be included.

SERVICE TO FSA-AGRICULTURE: How long has nominee worked for FSA? What program or special project have they worked with? Size of county and number of farmers served? Any outstanding contribution to FSA and /or Agriculture? Has nominee received any special awards or promotions? NASCOE background and any other pertinent information can also be included.

COMMUNITY SERVICE: What organization(s) has nominee worked with? Do they hold an office or any special committee assignment? Their church affiliation, family status, children, etc. What has nominee done to improve the community he/she lives in? Any special recognition received? FSA and NASCOE background and any other pertinent information can also be included.

### LENGTH OF NOMINATION

A nomination should be brief, factual, and specific! It cannot exceed two (2) double-spaced typewritten 81/2" X 11" pages, plus the cover sheet. The pages must not be reduced by photocopier or other means to enable more print on the two pages. No attachments, and conclusions not backed by facts should be avoided. Specific examples and details should be given to support the nomination.

### SUBMITTING NOMINATION

Mail the original and five (5) copies of the nomination to Attention – Connie Safley, Dallas County FSA, P.O. Box 70, Adel, Iowa 50003 before February 1<sup>st,</sup> 2006. # <u>2006 IASCOE SCHOLARSHIPS</u>

All applications may be found at the NASCOE website, <a href="www.nascoe.org">www.nascoe.org</a> In order to print the application, access the web-site and look for the scholarship button on the left side and click. On the next page, click on "scholarship application". This is now a fillable form and you may complete the application by typing in the information. Once you have completed all pages (5) of the application, print the document and sign as required. Be sure to print the scholarship application checklist in order to assure that you have all supporting documents included when you mail the application to me.

The IASCOE scholarship application MUST be returned to <u>Cindy Pistek</u>, <u>2145 Maple Ave</u>, <u>Britt</u>, <u>IA</u> 50423 by **January 31**, **2006**.

# Eligibility:

- 1. Applicant must be an IASCOE/NASCOE member, member's spouse, or member's legal dependent. The member must be a county FSA employee who has their dues paid and membership current for the past 5 consecutive years or since becoming a permanent FSA employee, whichever is less
- 2. Applicant must be either a high school senior or graduate with a minimum of a "C" average in both the junior and senior year **or** may be a full-time (minimum of 12 credit hours) college student with a minimum of a "C" average up to the Bachelor Degree level.

### **Instructions:**

- 1. Complete this **application** if you meet the criteria above. Your state scholarship chairperson (Cindy Pistek) must receive it no later than **January 31, 2006.**
- 2. Include an **official transcript** of your high school grades and a **letter of recommendation**. If you are a college student, include an official (copy) transcript of your grades. College students must also include a high school transcript if they wish to have them considered for rating.
- 3. All grade point averages must be on a scale using the 4.0 system. Letter or numerical grades need to be converted by your counselor.
- 4. Area winners will be asked to submit a recent color photograph.
- 5. Please type or print legibly in ink.
- 6. Keep a copy of this application for your records.

Please make sure that all of the following are attached or enclosed, as required, with our application. Failure on your part to provide the required information may result in your application not being considered. Copes of transcripts are acceptable.

# What Is On The Horizon For NASCOE?

FY06 - near future... FSA Tomorrow has only been set aside and we will face a similar plan in the future, Budget is a problem and management will be faced with making hard choices to live within the budget, as I write this we do not have 2006 staff ceilings but staff ceilings will be based on how much money is available in the budget. As seems to be the norm the past few years, FSA Employees and NASCOE will have a "hard row to hoe" to get through FY06. There have been some changes in our FSA Management, which will undoubtedly bring changes for us as FSA employees and NASCOE members. Teresa Lasseter is our new Administrator. Ms. Lasseter's profile shows that she has been an employee of FSA for many years and has held many positions within FSA - county office, state office, and in WDC. Dan and I have both visited with Ms. Lasseter and look forward to working with her. Steve Connelly has been appointed as the new DAFO replacing Doug Frago. Mr. Connelly has served as SED of Maryland and more recently as Deputy Administrator for Farm Programs. Many of you who attended the NASCOE convention in Rapid City may have visited with him there. Although we will miss Doug we wish him well in his retirement and hope he will visit with us when he has an opportunity. Again, Dan and I have both also visited with Steve and we are looking forward to working with him. There may be other changes in management that we are not aware of at this time. As far as we know John Chott and Linda Treese will remain in their current positions as Assistants to DAFO and will be very helpful to Mr. Connelly as the new DAFO. I know that we will continue to have a great working relationship with the folks in the DAFO shop.

FY07 and beyond... Legislation has been introduced to extend the 2002 Farm Bill through 2008 and if passed will delay the next Farm Bill by one year. However, NASCOE leadership must be forward thinking. For at least 3 years NASCOE leadership and Legislative Team have been discussing strategy, formulating plans, and taking the first initial steps of NASCOE's course of action for the 2007 Farm Bill. On this subject, I hope that each of you either attended the Farm Bill Forum in your area or responded via the internet with your comments on the next Farm Bill. As I write this it isn't too late to submit comments if you wish to do so. Examples of write-in comments are available to get you started, and can be obtained from Trice Smith or me. One of the most important questions I think NASCOE leadership can ask of membership is their thoughts/wishes for their future with FSA and NASCOE and what can we do to get there. So, "What are your thoughts - what do you want for your future with FSA and NASCOE, and what are your thoughts on what we should do to get there?" The form is available on-line at <a href="www.nascoe.org">www.nascoe.org</a> under the Negotiations page, or can be obtained from your Area Exec Mark VanHoose or Area Negotiation Consultant Betsy Mace. It is important that each of you submit issues that affect your daily working life that you believe can be improved. Daily issues sometimes seem like minor issues compared to things such as budget and staffing, but the minor issues are important to consider also. Again, we want to hear from you.

Suspensions, Dismissals, OTI's, Reprimands, Etc. – Most everyone is aware that the procedures for Adverse Actions have changed. The changes were effective August 1, 2005. Unfortunately, updated versions of Handbook 22-PM reflecting these changes have not been received in our FSA field offices. This can leave our membership in a bit of a dilemma. If you have a reason to question what your rights might be you may not want to contact your STO for guidance/information. If you find yourself in this situation and you believe NASCOE can assist you, please contact your State President to request NASCOE's assistance. The process for requesting assistance can be read at <a href="https://www.nascoe.org">www.nascoe.org</a> under the Vice President's page.

# **LEGISLATIVE CONFERENCE INFORMATION**

The contract with the hotel for a full 2006 Legislative Conference has now been finalized.

The conference particulars are as follows:

Dates: Monday February 27 - Thursday March 2.

Participants Arrival: Monday February 27 Participants Departure: Thursday March 2

Participants in the conference will make plans to arrive on Monday with training and speakers on Tuesday, visit congressional offices on Wednesday/Thursday and return home on Thursday. It seems to be a very busy week in D.C. as rooms were difficult to obtain. As soon as we receive the group number for making reservations the Area Legislative Chairs will be getting that and other items out to the states. We are encouraging the states to bring a producer from their state to be a participant in the conference and a coalition partner in the visits on the hill. This will be done at the states expense so make plans now.

## LEGISLATIVE EDUCATION TRIP

Brent Orr has graciously volunteered to plan and host our first Legislative Congressional Staff education trip. This recommendation was made at the national convention and money had been previously been set aside for this trip. Brent has planned a Duck Hunt and Trap Shoot for the 8-10 staffers, along with producers from his state. Robert Redding and Brent are working together to decide who will attend this event. The education trip will also include a visit to a couple of county offices within the area. NASCOE feels that this meeting will prove very positive for our organization. With the new farm bill on the horizon we need to "branch out" into other avenues of communication.

### BUDGET

The FY 2006 Conference Report was approved on October 28, 2005 and signed by the President on November 10<sup>th</sup>. Salary and Expense dollars ended up somewhere in between the House and the Senates requests and is \$30M over the 2005 level but still is significantly below what we need. This is a short recap on the funding for S&E's:

Presidents Request - \$1,365.1 M Conference Actions- \$1.339.7 M

(\$25.4)

Add in the 3% COLA (\$ 7.1)

2% Rescission makes it a total of (\$27.7) shortfall for S&E's for 2006.

The total shortfall for FSA is somewhere around \$70M.

This of course will have a definite impact on the operation of the county office.

# **STAFFING**

FSA Tomorrow is not really a dead issue, it has just been rerouted to a different approach. The producers and community stakeholders will now have the chance to come forward at a public forum or meeting and make their case for keeping an office open or maybe to even be in approval of closing the county office. This is what NASCOE wanted. We wanted stakeholders at the table with fair and justifiable reasons to close a county office. There have been no promises or commitments that monetary savings from consolidations of county offices would be retained in the state or applied to staffing. Therefore the closures may not have helped us with the current staffing situation. Savings from the FSA Tomorrow plan would not be seen until FY 2007. The Department is telling NASCOE that FSA Tomorrow would have cost FSA \$6M in the first year and then any savings would begin to show in 2007. The withdrawal of FSA Tomorrow by the department will not be responsible for the word RIF because by all accounts, it looks as if there were already plans in place for staff reductions in our future. The Department officials made continually stated as "unclear" how many jobs would be eliminated by FSA Tomorrow. Once offices were consolidated could we believe that the agency would allow us to keep 2 clerks for every program? Not when they thought that IT efficiencies for our program operations were in place!

Until DAFO is provided the final FY 2006 staffing ceilings we are operating under the ceilings that were provided by DAFO in September. Dan has been promised by DAFO that he will get the numbers as soon as they do. Until then we do not know what we are up against. The latest numbers on the buyouts show 291 taken for CO and 63 for GS. This falls about 41 short of what the agency wanted. Could there be a possible 2<sup>nd</sup> buyout? Another buyout would further compromise the county office by dealing with less staff and excess workload. NASCOE is developing an open door policy with the new administrator and will continue to make her aware of the possibilities that FSA has as a county-based operation.

# PROGRAM CUTS For The THE RECONCILIATION ACT.

Following are the cuts proposed in the House and Senate. They will now go to conference committee for agreement. Probably will not be completed until December.

# **House Side Reduction**

Reduces direct payments by 1% for each fiscal year 2006-2009

Reduces the direct peanut payments by 1% for FYs 2006-2009

Reduces the Direct Advance payment amounts for FY 2006-2007 from 50% to 40%

Repeals the Step 2 program for upland cotton

Reduces Watershed programs by 15M and rescinds the funds that were previously made available and not used.

Limits funds for CSP for 2006-2010 to \$2.2B and Increases funding for CSP to \$5.7 for fiscal years 2006-2015.

## **Senate Side Reduction**

The Senate reconciliation package was passed about 2 Weeks ago including several cuts to Agriculture.

Proposed 2.5 % reduction in farm program payments

Advance Payment reduction amounts from 50% to 40% for 2006 and reduced to 29% for 2007-2011 crop years.

Cap on CSP to \$1.954 B for years 2006-2010

A forfeiture penalty on non-recourse sugar loans

Extension of the MILC program

## **House Ag Democrats Introduce Farm Bill Extension**

Collin Peterson (Minnesota) and Jim Costa (California) have entered legislation (HR4332) to extend the 2002 Farm Bill thru fiscal or calendar year 2008 depending on the completion of the Doha Round talks. This bill currently has 16 supporters.

# News From Your MWA Executive!

I want to thank the Iowa association for this opportunity to share some information from the area level and I wish all of you the best during the holiday season. With so many work pressures it is difficult to take some time off but I hope you make sure to spend time with family this Christmas season.

NASCOE goes to Washington! Your officers and execs will be going to Washington to meet with FSA leadership December 13th and 14<sup>th</sup>. I especially look forward to meeting with our new Administrator and hearing her vision for our future. We will also meet with staffers in Farm Programs, Information Technology, Human Resources, Budget, Management, Conservation and our new Deputy Administrator for Field Operations Steve Connelly. I have lots of questions about office closure plans and nuts and bolts issues like needing the GIS mess on more than one computer! Hopefully management will have some answers. We will also follow up on promises made last year that we have not seen progress on concerning negotiation items. I will report to you after returning home.

Membership has its privileges! Congratulations to lowa for being one of two states in the Midwest Area with an increased membership percentage over last year! Your percentage last year was an excellent 86 percent and you increased a whole percentage point to 87 percent. That isn't easy to do in this time of uncertainty and I commend your dedication to NASCOE. Indiana was the other state with an increase in membership. Overall, nationally we are at 79 percent but that is partially due to some states not getting dues in timely. Last years final membership percentage was 83. A high membership percentage sends the message to management that county office employees have confidence in their organization to represent their interests and I appreciate your State's leadership in this area. Last year the Midwest Area had a total membership of 84 percent and this was just behind the Southeast Area's percentage of 86. I am hopeful we can be the number one area this year in membership percentage and I appreciate the work of our Area Membership Chair Will Herr for his efforts.

Capwizing for our future. Many of you are familiar with our electronic messaging system to send our message to Congress. Capwiz can provide you with the message and the correct Congress contacts to send the message on NASCOE issues. With 7500 potential members to enroll, we currently have 2895 registered nationally to receive Capwiz legislative alerts. And guess who leads the pack for Capwiz registration in the Midwest Area? Iowa, of course, with 216 registered! The Midwest Area has a total of 865 registered, which is an impressive 30 percent of the national figure. I commend your state for being one of the first to have a Capwiz Coordinator and your registration numbers reflect your commitment to this effort. I want to encourage you to continue your efforts to get every Iowa member enrolled and also look to area agriculture leaders to participate. As the 2007 budget and Farm Bill process begins in the spring of 2006 it will be very important to have as many Capwiz enrollees as we can to spread our message.

commendably named Associate Administrator for Programs in Washington, D.C. From 2003 to 2004, Lasseter was responsible for supervising and administering farm commodity programs, farm loans, conservation programs, and disaster assistance.

Before assuming her current position, Lasseter was involved in Lasseter Tractor Company and the development of commercial property in Moultrie, GA. Lasseter was appointed to the Georgia Ports Authority Board by the governor of Georgia and also served on the South Georgia Businesses for Economic Development board. Lasseter, a native of Tifton, Georgia, also served six years as the Executive Director of Georgia Agrirama Development Authority.

Throughout her career, Lasseter has received recognition and numerous awards for her exemplary work. In 1991, she received the Unsung Hero Award for exemplifying the spirit of public service. An honor graduate from the Abraham Baldwin Agricultural College, Lasseter holds a degree in Business Administration.

Lasseter has two children. She and her husband, Willard, live in Arlington, Virginia.



The reason we came to Waveland was because we had personal information about the city. My preacher is the former football coach at a Catholic school just outside of Waveland. The mayor of Waveland is one of his former

football players. Although not doing much, we were able to provide a lunch meal to the city employees of Waveland. They are all living in RVs in a state park on the east side of Waveland.

The mayor tells the story of the day of the storm. He was thankful that the storm came during the day. If it had been at night, there would have been many more casualties because people would have not been able to swim. The mayor spent the time of the storm in a waste treatment facility with two floors and an elevator. The last two ladies to evacuate to the second floor wound up being trapped in the elevator because the electricity went off as they were moving from the 1<sup>st</sup> to the 2<sup>nd</sup> floor. The mayor said he could hear their screams. They were forced to cut a whole in 4 inch thick concrete to get into the elevator shaft as the water was rising. This is indeed a miracle. The mayor had just had knee replacement surgery a week before the storm.

# Combined Federal Campaign (CFC)

The mission of the CFC is to support and to promote philanthropy through a voluntary program that is employee-focused, cost-efficient and effective in providing all Federal employees the opportunity to improve the quality of life for all.

### What is the CFC?

The CFC is the only authorized solicitation of employees in the Federal workplace on behalf of charitable organizations. It continues to be the largest and most successful workplace fundraising model in the world. With a tradition of commitment to the community through the selfless efforts of Federal employees, the CFC has its roots in the many charitable campaigns of the early 1960's. Seeing a need to bring the diversity of fundraising efforts under one umbrella, the CFC was created – one campaign, once a year. In 2004, Federal employees around the world raised more than \$256 million for charitable causes.

## Structure of the CFC

The CFC is made up of local campaigns that raise funds in Federal workplaces across the country and around the world. Local charities that serve the local area or adjacent counties apply directly to a Local Federal Coordinating Committee (LFCC) – which serves as a "Board of Directors" of the local CFC. The LFCC is composed of Federal employees and representatives of labor unions with Federal employees as members. Decisions regarding the inclusion of charities in the local campaigns are made by the LFCC. LFCCs are also responsible for the oversight of the local CFC in conformance with the CFC regulations and policies promulgated by the Office of Personnel Management (OPM). All organizations participating in the campaigns must meet strict public accountability criteria set forth in OPM regulations.

Every year, the LFCC selects one of the voluntary organizations involved in the local CFC to serve as the Principal Combined Fund Organization (PCFO), whose job it is to manage the campaign and serve as fiscal agent. OPM sets strict requirements for this role. Annual audits are required of the PCFO by an independent CPA.

OPM is responsible for regulating the CFC, providing guidance and oversight nationwide, and also has the authority to conduct compliance audits on any CFC local campaign fiscal records.

# ATTORNEY'S ADVICE----NO CHARGE

- 1. The next time you order checks have only your initials (instead of first name) and last name put on them. If someone takes your checkbook, they will not know if you sign your checks with just your initials or your first name, but your bank will know how you sign your checks.
- 2. Do not sign the back of your credit cards. Instead, put "PHOTO ID REQUIRED."
- 3. When you are writing checks to pay on your credit card accounts, DO NOT put the complete account number on the "For" line. Instead, just put the last four numbers. The credit card company knows the rest of the number, and anyone who might be handling your check as it passes through all the check-processing channels will not have access to it.
- 4. Put your work phone # on your checks instead of your home phone. If you have a PO Box, use that instead of your home address. If you do not have a PO Box, use your work address. Never have your SS# printed on your checks, (DUH!). You can add it if it is necessary. However, if you have it printed, anyone can get it.
- 5. Place the contents of your wallet on a photocopy machine. Do both sides of each license, credit card, etc. You will know what you had in your wallet and all of the account numbers and phone numbers to call and cancel. Keep the photocopy in a safe place. Also carry a photocopy of your passport when traveling either here or abroad. We have all heard horror stories about fraud that is committed on us in stealing a name, address, Social Security number, and credit cards.
- 6. When you check out of a hotel that uses cards for keys (and they all seem to do that now), do not turn the "keys" in. Take them with you and destroy them. Those little cards have on them all of the information you gave the hotel, including address and credit card numbers and expiration dates. Someone with a card reader, or employee of the hotel, can access all that information with no problem whatsoever.

Unfortunately, as an attorney, I have first hand knowledge because my wallet was stolen last month. Within a week, the thieve(s) ordered an expensive monthly cell phone package, applied for a VISA credit card, had a credit line approved to buy a Gateway computer and received a PIN number from DMV to change my driving record information online. Here is some critical information to limit the damage in case this happens to you or someone you know:

- 1. We have been told we should cancel our credit cards immediately. The key is having the toll free numbers and your card numbers handy so you know whom to call. Keep those where you can find them.
- 2. File a police report immediately in the jurisdiction where your credit cards, etc., were stolen. This proves to credit providers you were diligent, and this is a first step toward an investigation (if there ever is one). However, here is what is perhaps most important of all (I never even thought to do this.)
- 3. Call the three national credit-reporting organizations immediately to place a fraud alert on your name and Social Security number. I had never heard of doing that until advised by a bank that called to tell me an application for credit was made over the Internet in my name. The alert means any company that checks your credit knows your information was stolen, and they have to contact you by phone to authorize new credit. By the time I was advised to do this, almost two weeks after the theft, all the damage had been done. There are records of all the credit checks initiated by the thieves' purchases, none of which I knew about before placing the alert. Since then, no additional damage has been done, and the thieves threw my wallet away this weekend (someone turned it in). It seems to have stopped them dead in their tracks.

Now, here are the numbers you always need to contact about your wallet and contents being stolen:

- 1.) Equifax: 1-800-525-6285
- 2.) Experian (formerly TRW): 1-888-397-3742
- 3.) Trans Union: 1-800-680-7289
- 4.) Social Security Administration (fraud line): 1-800-269-0271

We pass along jokes on the Internet, we pass along just about everything.

Nevertheless, if you are willing to pass this information along, it could really help someone about who you care.





Serve with crackers, chips, and or veggies. Whoa!! It's the best



# **Fudge**

Into a large bowl, put 2 or 3 German Sweet Chocolate bars broken into small pieces. Add the following:

2 - 12 oz pkgs chocolate chips

1 pint jar marshmallow creme

2 tsp vanilla

1 cup chopped nuts

sprinkle 2 Tsp vinegar and set aside for 1 hour

In a large kettle mix

4 1/2 cups sugar

1 large can evaporated milk

1 Tsp butter

Bring to a rolling boil for 5 minutes.

Pour chocolate over mixture and stir until melted. Pour in jellyroll pan until set. Cut into 1" squares

This recipe is very good and never gets hard or sugary.

# **Sugar Cookies**

1 c. powdered sugar 1 tsp. vanilla

1 c. White sugar 1/2 tsp. cream of tartar

2 sticks oleo 1/2 tsp. soda

2 eggs 4 cups plus 4 TSP Flour

1 c. corn oil

Mix in order given. Chill 1 hour. Form into balls, roll in white sugar and flatten with a glass. Bake at 350 for 8 to 10 min. Note - You can frost or decorate if you desire.

# **Easy Raspberry Dessert**

1 box Betty Crocker white angel food cake mix.

1 1/4 cups cold water

1 box (8 serving size) sugar free raspberry jello

2 cups boiling water

2 boxes (10 oz) frozen sweetened raspberries thawed

3 containers (6 oz) Yoplait Original 99% fat free red raspberry yogurt

Heat oven to 350. In extra large glass or metal bowl, beat cake mix and cold water. Pour into ungreased tube pan. Bake 37-47 min. or until top is dark golden brown and cracks feel very dry and not sticky.

Cool cake upside down (in pan) on narrow necked glass bottle or heatproof surface 1 hour or until completely cooled. Loosen edges with flat knife or metal spatula to remove from pan. Tear cake into 3/4 inches pieces.

Place gelatin in large bowl. Pour boiling water over gelatin, Stir until dissolved. Gently stir raspberries into gelatin. Refrigerate gelatin mixture about 15 minutes or until thickened but not set.

Layer half of each of cake pieces, gelatin mixture and yogurt in 3-qt glass bowl, repeat. Garnish with reserved raspberries. Refrigerate at least 2 hour until firm. Cover and refrigerate any remaining dessert.

# **Eggnog Ice Cream**

4 C. milk
8 eggs, beaten
2 1/4 C. sugar
1/2 tsp. salt
10 T. brandy
2 T. vanilla extract
3/4 tsp. ground nutmeg
1/4 tsp. ground cinnamon

4 C. whipping cream

Warm milk; add eggs, sugar and salt. Cook, stirring constantly, until temperature reaches 155?F or until mixture coats the back of a spoon. Do not overcook. Remove from heat and add cream. Stir occasionally while mixture cools.

In separate bowl combine brandy, vanilla extract, nutmeg and cinnamon. Beat flavorings into cooled custard mixture. Freeze in ice cream freezer. Pack to let ice cream set up. Makes 1 gallon.

# **Holiday Crescent Cookies**

1/2 lb. butter (2 sticks) 2 tsp. vanilla 2 c. flour 1 tbsp. water 2 c. chopped pecans 1/2 tsp. salt

5 tbsp. sugar

Cream butter and sugar; add vanilla and water. Sift flour and salt, stir into mixture. Add pecans and mix well. Shape into size of walnut and shape into crescent. Bake slowly at 325 degrees about 20 minutes. While warm, roll into powdered sugar.

# **Holiday Fudge**

1 cup sugar 2 cups powdered sugar

½ cup butter 1 tsp vanilla

½ cup heavy cream½ cup red candied cherries, chopped½ tsp salt½ cup green candied cherries, chopped

Spray an 8x8" baking dish with cooking spray. In a large saucepan, bring the sugar, butter, cream and salt to a boil over medium heat, stirring frequently. Let boil for 5 minutes, stirring constantly. Remove from heat and slowly add the powdered sugar and vanilla, stirring until smooth and well combined. Stir in the cherries until evenly distributed. Spoon into baking dish and chill for 1 hour or until firm. Cut into squares. Store in an airtight container.
