A Message from our State Executive Director



Many years ago when I was President of the Iowa Farmer's Union, I was engaged in a lively discussion with someone about an issue in agriculture. The "discussion" reached the point where the other person said, "Everything changes, there is nothing constant, and you can either change with the rest of us or get run over." As I thought about that statement, I realized that what I was doing at the time was not standing in the way but instead, trying to shape change. I came to the conclusion that there is one thing which is constant and that is change. We do not stand in the way of change, we shape it. Secretary Vilsack recently held a conference call with all members of the State Committees and the SEDs. During the call, the Secretary made the statement that 'if we do not manage change, change will manage us.'

As I am writing this, we are under a Continuing Resolution (CR) but do not know what our allotments are for the CR. We are not certain if there will be changes to the Farm Bill. We are hearing rumors of more downsizing within the agency. As of right now, these are only rumors; there are no facts to go on. We know that we will not be operating as were even one year ago, but we don't know yet what will shape our operation.

I can tell you that there are discussions occurring centered on the structure of our agency. We need a way to gauge how many staff we need doing each job and where the staff is needed. Does all policy work need to be done in Washington D.C. or can some be done at the STO level? Are there CO staff who could help answer the day-to-day program questions which come up? Actually, I know the answer to that one, and it is yes! How much repetition occurs between agencies within the Department?

We have many issues to work through. I can tell you that I believe there will be another VERA as like most states, we did not reach our new targeted ceiling with the VSIP. I can also tell you that I have been assured by everyone in D.C. that whoever wants to continue with FSA will have a job. From there, all else is just rumors.

FSA is known as a "can do" agency. Whatever we are asked to do, we will find a way to get it done!

Benefit Update

As I was preparing for the quarterly directors meeting of IASCOE on October 29th, I thought I better take a look at the NASCOE.org website and go under the benefits tab to see if anything new was listed. Boy was I surprised. I hadn't been to the website for a few weeks and things had changed. I clicked on the Benefits Available to all Federal Employees tab (by the cute little gecko) and found a listing of several great discounts available to Government workers. There are discounts for eye care, resume writing, cell phone packages, rental cars, travel and a variety of other things. If you are traveling, there are several hotel chains that offer special rates to government employees. Go to the website and click on the tab and see for yourself.

One of the listings I found interesting was the Government Employees Marketplace. It is free to join and is exclusive to Government workers. You can find this marketplace at https://gem.onebigplanet.com/d/public/login.html. I couldn't believe all the discounts on the website. There were discounts to big name stores such as Target, Office Depot, Best Buy, and many more. After registering the site knows where I live and there were lots of discounts under the local tab to businesses and restaurants in my surrounding area. What a great discovery for me as I start my Christmas shopping.

Some of the benefits listed on the NASCOE.org benefits page require a Members only password. If you have already gotten your password but can't remember what it is send an email to Tammy Eibey. She will look and see what your password is. NASCOE has to pay for the password pro feature and only has 1000 accounts so please don't just request a new password using a different user id.

In these uncertain times it is nice to learn I have even more benefits than I realized being a Government worker. I know I am glad I have my 2011-2012 National Association of FSA County Office Employees Official Membership Card to carry in my purse.

















What Are YOU Thinking!?

What are they thinking? Don't they know what that will do to me? How is that going to work? Why are they doing that? Wasn't there something else they could have done?

How often have you asked these questions when congress makes a decision? These could be decisions on programs, the budget, or the benefits that we as FSA and Federal employees are responsible for or receive. I think all of us realize that they have a tough job to do but we would hope they could arrive at the best possible option before making their final decisions. When you make a major decision in your life such as buying a car or house or what college your child may attend, you look at your options and take many things into consideration. In the end, you make the decision based on the information and resources you have available. NASCOE has invested in CAP WIZ so NASCOE members can provide our Senators and Representatives in Washington with information and options they can consider when making important decisions that will impact FSA and in particular CO employees. NASCOE looks at legislation that is being proposed, hearings being held, or important events such Farm Bill deliberations, and determines what impact it will have on FSA CO employees and establishes a position on the issue. A letter is written on the position and is posted to the Cap Wiz alert system. All of those that are subscribed to Cap Wiz will receive an alert on their home email asking that they take action on the topic. Everyone who takes action sends the same message to their Representative and Senators whether they are from Manchester, or Sioux City, Iowa or Georgia. The more people sending the same message, the more people will hear it in Washington. The goal is to educate and inform them so they can make the best decision that will be of the most benefit (or do the least amount of harm) to FSA and the county office employees.

There were two recent Cap Wiz alerts that were sent out. The first was on Dairy legislation. Whether you agree with the legislation or not, the important thing is that we/FSA want to administer this program. That is the message that we need to send. This could have a significant impact on FSA workload in the Midwest and in lowa particularly. The second alert was regarding the reduction in the field office staff in order to meet the 2012 and 2013 budgets for FSA. NASCOE wants congress to make sure FSA management looks at all levels of the agency for staff reductions and not just those at the delivery point. Options and suggestions were included that would provide significant savings quicker and more effectively than eliminating staff at the county level.

The letters were written and with a couple of clicks you were able to send your message to your two Senators and Representative in Washington. How much easier could it be?

There are currently 4175 subscribers nationally to CAP WIZ. Iowa has 336 which is a great percentage of our membership. Unfortunately we haven't been sending these alerts to congress. When the Dairy alert was sent out only 781 people nationally and 73 from IA sent the message! When the FSA Reduction alert was sent out 946 CAP WIZ subscribers sent messages but only 107 from IA.

Now I have to ask; What are YOU thinking! Don't YOU want your Representative and Senators to know how their vote will impact YOU? Don't YOU want them to look at ALL of the options available before they start eliminating positions at the county level? Don't YOU want them to know that YOU are concerned! CAP WIZ can be and has been an effective tool in delivering messages to congress but only when it is used by the members. If we fail to educate congress on issues that are important to us or fail to let them know we are concerned about an issue they will make decision based on what someone else is saying. Do YOU want to take the chance they are protecting your interests? I certainly don't!

Less than 35% of IA CAP WIZ subscribers took action on the last two alerts we can and must do a better job of informing our people in Washington if we hope to remain a viable option in the delivery of farm programs to America's farmers and ranchers. If we are a viable option we will all be a victim of the budget cuts and lose our best benefit, our jobs!

If you have any questions or concerns about the letters in CAP WIZ or how NASCOE uses it please let me know. NASCOE signs a contract for this service and we need our membership to utilize it to justify the cost. If you don't like the alerts or messages being sent, you need to let NASCOE know what message should be sent, let your area directors and State Officers know what YOU are thinking. Don't let others speak for you.
