

NASCOE Amplifies Voices!

Recently I had an amazing opportunity to represent IASCOE as a special guest at the State of the Union Address in Washington D.C. This was an historic experience and I was honored to attend something I would normally watch on primetime TV. It's hard to put into words the mere fact that I was sitting yards away from the President of the United States and few feet away from the First family. It sounds cheesy, but it was a pretty darn cool experience.

The biggest message I must share with our membership is not the actual event but the message that resonated with Congresswoman Abby Finkenauer of District 1. I shared the stories I received from members personally or been told details from others. I tried to communicate all your messages to our elected leaders, but I know I couldn't hear them all. I shared with them stories about an employee who just recently went on maternity leave and is now uncertain about their leave status during the shutdown and being recalled, I shared about employees incurring major travel expenses driving 75-100 miles round trip to work with no pay, I shared about employees who are single income families and having a hard time trying to make ends meet, I shared about employees who are going to be saddled with considerable daycare expenses by going back to work with no pay, I shared about employees who are farmers themselves and are struggling and are now going to work with no pay, and finally I shared about unemployment benefits being lost due to our "Excepted On Call" status.

I am here to reassure you that your representatives are listening. Your personal stories matter, and they mean something. Our elected leaders want and most importantly, need to hear from you again and again and again. NASCOE allowed me to amplify our message. But what NASCOE / IASCOE represents is bigger than one person, its all of us working together to do a job we love and making a positive impact in our local communities.

Your membership to NASCOE has never been more important than it is today and the impact was on full display during the longest shut down in history as both NASCOE / IASCOE were there to keep you informed with regular emails and helpful furlough updates on the NASCOE website. It is a reassuring feeling to have an organization that is working so hard on our behalf.

The NASCOE negotiations process is arguably the most important function of this association. Members just like you, are afforded the opportunity to submit improvement ideas that will be negotiated on your behalf with management. As part of this process, there is a planning meeting that is historically scheduled during the MLK holiday, to review these items and determine how best to proceed with each item. Unfortunately, this year, this happened during a period of government shutdown.

Because the end of the shutdown could not be predicted, NASCOE has no choice to proceed with business as usual. Hotel contracts had been signed, flights booked, plans made. It would have been expensive to cancel this meeting and reschedule during a time when the government was back to open status.

The good news is that regardless of the status of the government, NASCOE is still working for you! There were nearly 70 negotiation items that were submitted. These items were reviewed and assigned to negotiation consultants to research and prepare to negotiate with management. There items dealing with IT issues, staffing, workload and other areas. There were issues submitted from every area.

More good news is that the MWA rally is still scheduled as planned. It is scheduled for March 14 – 16 in Champaign Illinois at I Hotel and Conference Center. There will be a murder mystery dinner Thursday night and for \$5 you can catch a shuttle to historical downtown. The deadline for reservations is February 14, 2019. Please make your plans now.

Final thought before closing, I appreciate the efforts of all state, area and national Chairs in each of their respective areas. I also greatly appreciate the efforts of the state and national level leadership as well.
