



A Message from our State Executive Director



There is no other way to say it than, it has been a tough few months! The budget uncertainty that we have gone through has caused sleepless nights at all levels of our agency. We now have the word that we will not have furlough days or even hours and this is good news, but the cost to all of us has been high. The interim ceiling has created a definite under staffed situation in many areas of the state and the then the hard hiring freeze has further complicated that situation. Every time I talk to staff in the field, I can detect the stress that employees are feeling, and I don't like that. I also realize that the only thing that is allowing some counties to cope is that this agency is a family and family looks out for each other! With everything that we have been through, I still believe that the light at the end of the tunnel is not the oncoming train.

In most cases, our producers are doing well, which can bring its own set of problems for us. I am concerned that in good times some producers push the limits on HEL Compliance and Wetland Compliance. There is a call in the media and by some farm groups to give producers crop insurance and that's it. I appreciate the advice of Representative Colin Peterson when he says that farm policy needs to look long term, not year to year. We all know that the only long-term farm policy is provided by FSA. We need to remind not only our producers of this, but also anyone else who asks.

One note to the IASCOE membership, I always enjoy work with your leadership for the good of our agency. Our travel budget does not allow me to get out and visit as much as I would like, so I rely on the phone calls and emails from your President as a small way to keep in touch. I appreciate the open, honest, and even frank discussions I have. So to all of you, and especially your leaders, past, present and future, Thank You!

A recap of what we learned in Atlantic.....

Introductions were done, logistics were given, the stage was set – let's get started; "first thing we are going to do is log in to the laptops so you can follow along with the simulators". So we did...and we waited...and we waited... Now as any good trainer knows the key to success in adult education is.......SWEETS! We were prepared, the candy bowl was passed and there was a counter full of homemade goodies – *ahh success*!

The training really did go well despite a few glitches with the computers, the training environment, and the occasional 'check out' by *one* of the trainers. ⁽²⁾ One thing we did learn is that we have some pretty fantastic 'cooks' within FSA that were kind enough to share their talents with us. Needless to say, between all the restaurants we patronized for lunch, the candy bowl, and the homemade goodies, this trainer is eating carrot sticks for the rest of the summer!

Here is a sampling of the goodies we had.

Toffee Chocolate Bars

Jennifer Comer, Page County Base: 3/4 c margarine,softened 3/4 c packed brown sugar 1 1/2 c flour

Topping: 10 oz can sweetened condensed milk 2 tbsp margarine 1 3/4 cups milk chocolate chips 1 1/3 c toffee bits

Base: Cream together margarine, brown sugar and flour until well blended and mixture sticks together. Press into 9x13 pan. Bake at 350 for 20-25 min or until light golden. Cool while preparing filling.

Filling: Heat sweetened condensed milk and margarine in heavy pan, stirring constantly over med heat for 5-10 min or until thickened. Spread over cooled base. Bake at 350 for 12-15 min or until golden. Sprinkle chocolate chips evenly over

the top. Bake for 2 min longer or until chocolate is shiny and soft. Remove from oven. Spread chocolate evenly. Sprinkle toffee bits on top, pressing lightly into chocolate. Cool completely and cut into bars.

Paula Deen's Lemon Bars

Jennifer Comer, Page County Crust: 2 cups all-purpose flour 1 cup confectioners' sugar, plus more for dusting Pinch salt 2 sticks butter, at room temperature, plus more for greasing

Filling:

4 eggs2 cups granulated sugar6 tablespoons all-purpose flour6 tablespoons fresh lemon juice

Directions

Preheat oven to 350 degrees F. Lightly grease a 9 by 13 by 2-inch pan.

Make the crust by combining the flour, confectioners' sugar, and salt in a large bowl. Cut in the butter to make a crumbly mixture. Press the mixture into the prepared pan. You may need to dip your fingers into a little flour or confectioners' sugar to keep the dough from sticking to your fingers. Bake for 20 minutes.

Meanwhile, to make the filling, mix the eggs, granulated sugar, flour, and lemon juice. Pour this over the baked crust and bake for 25 minutes longer. Sprinkle with confectioners' sugar, if desired, when the bars are done.

Monkey Bread

Pat Warmbier, Harrison County 18 Rhodes rolls 1 sm box of butterscotch pudding (cook type not instant) 1 stick of butter 1 cup dark brown sugar

The night before place the frozen rolls in a greased bundt pan. Sprinkle the dry pudding over rolls. Cover with foil or plastic wrap that has been sprayed with oil.

Next morning melt the stick of butter and brown sugar on stove top or microwave. Bring to a hard boil for about 30-45 seconds. Pour over rolls and bake at 350 degrees for 20-25 minutes. Let stand 5-10 minutes before inverting onto a plate.

You can also add chopped pecans if you like.

Puffcorn Snack

Pat Warmbier, Harrison County

1 bag of Puffycorn (hulless popcorn, I usually get the butter flavor) ½ package of white almond bark

Melt the almond bark in the microwave. Only takes about 1-3 minutes. Then pour over popcorn in a large bowl. Stir to coat over all of the popcorn. Spread out on wax paper to cool.

You can also add nuts, M & M's, pretzels or anything to your liking to mix with the popcorn. If you add M& M's to the mix, do at the very end of mixing right before you spread out on the wax paper so they do not start to melt.

NASCOE Benefits

These are troubling times as we all know. Every day, we hear about furloughs, office closures, pay freezes and threats to our federal employee benefits. Just keep in mind, the as NASCOE members, we do have benefits that are protected.

I would encourage everyone to take a look at the NASCOE website as several changes have been made on the Site. For example; all cell phone discounts and theme park discounts have been moved to the "Members Only" web page to keep those discounts exclusively for NASCOE members. The Sam Club discount remains under the "Members Only" page and the current Sam Club discount continues through December 31, 2013. Members needing a sign on id and password for the "Members Only" page should contact Deb Esselman-Baird of Wisconsin to obtain such.

US Cellular customers need to check their monthly bill to ensure they are still getting that discount. US Cellular requires government employees to verify employment every 2 years to remain eligible for this discount. Members should contact a U.S. Cellular representative to re-instate the discount if that discount is no longer being applied to the monthly charges.

In addition to the theme park discounts found on the "Members Only" page, Dee has discount coupons on hand for Adventureland in Des Moines, Iowa and Holiday World in Santa Claus, Indiana. Requests for Disney parks discounts continue to come in each year, however, Disney has not offered NASCOE members a direct discount for many years. Those members seeking a package deal for a trip to a Disney Park should check the NASCOE Travel Page or a Disney website.

Trevor Gartner of J M Marketing presented information at the MidWest Area rally. J M Marketing's products range from a variety of products including: a cancer policy, accidental death/dismember policy, dental policy, vision policy, long term care policy and term life insurance policy. In addition, J M Marketing now offers theft identity options and prepaid legal services. Members can also request a confidential benefits analysis which gives insight to projected retirement annuity, FERS supplemental benefit and TSP balance.

J M is currently pursuing the possibilities of providing an employee interest-free purchasing program, a short-term group disability policy, a group life insurance policy as an alternative to FEGLI and a home/auto discount insurance policy.

These benefits are also available to NAFEC members and RASCOE members as well as NASCOE associate members.

Later in the afternoon, Bibi sends me an IM about a missing 933 that she found on my desk (we'd searched and searched for it the day before)


>SBTA< I responded.


