#### FROM THE DESK OF DERRYL MCLAREN, SED

Thank you for your trust and patience! Instead of spending months-on-end anguishing over the Farm Bill "what-ifs", you have been productive in clearing your desks of routine tasks. The longer the Farm Bill debate dragged on, the more familiar it became. The political process DOES work, and, with a little tweaking, we will get Iowa's farmers signed-up and paid in the four months remaining of the fiscal year.

Get ready for implementation of the new legislation. The Farm Bill is very familiar, especially for 2008. It had to be! We don't have the luxury of time to deal with new programs or eligibility requirements. Our lawmakers realized that, and they wisely delayed authorization of the new programs until the 2009 crop year. In due time, the acronyms of ACRE and SURE will become part of our vocabulary, and we will do our best to provide enough knowledge to make you conversational, in the near term. Thankfully, the full details for these new revenue guarantee and permanent disaster programs will be provided in National and State-wide training this Fall and Winter.

So what is the task at hand? Well, first we will take acreage certifications, as we always have, in the month of June. While we are doing that, Washington will be providing direction on the issues of eligibility forms, such as 526's, 1026's, 502's, and 211's. So look for early July as a target date for all of the eligibility issues and paperwork requirements to be resolved. At that point, we can start signing-up producers and gathering signatures. I realize it only leaves us three months, but we knew the time-frame would be "tight".

While you are busy with the Farm Bill, Administration will be receiving input from Washington on Linc Pass (HSPD-12), Gov Trip, ARS (workload reporting), BPMS, and your favorite, Performance Management. Don't get me started!! Better than anyone in the State, I know how upsetting and traumatizing the transition has been from a pass/fail system of performance evaluation to a rating system carrying monetary rewards. Maybe Washington HR will have the answers for us at the SED/AO Conference in June. They are devoting over three hours to the subject, so it is certainly on their radar screen. In any event, it is necessary in any organization for management to establish the latitude and retain the prerogative in rating the performance of its employees.

We all know what is expected of us at work, but you have a personal life, as well. As we gather together for summer activities with family and friends, let us not only count our blessings but also share with the less fortunate such as those in Parkersburg and surrounding areas that have recently experienced the brutal forces of Nature. We have much to be thankful for!

# MIDWEST AREA EXECUTIVE REPORT

#### June 2008

It is hard for me to believe that my first year as Area Exec is coming to an end. It was a great learning experience as five new Area Execs, three new officers, and several new National Committee Chairs assumed their duties. After a slow start, I think the Executive committee came together very well.

Several things have been developed or improved with the new group that will be of great benefit to NASCOE and the general membership. A task force developed three position descriptions that have been submitted to HRD for review. These positions represent actual duties that are being performed by PTs in the field and may qualify at a higher grade if approved. Although this won't result in a blanket PT upgrade, we hope it provide upward mobility for some PTs and that it will stimulate a positive discussion about the knowledge, skills and abilities of all PTs.

We are in the early stages of developing a National Data Base for NASCOE which will allow NASCOE to communicate with members without using government equipment.

A Reorganization task force was developed to seek input from the members in the event FSA and NASCOE are involved with USDA reorganization. This task force raised questions and identified issues that need to be considered during any kind of USDA reorganization.

The recent negotiation session with management raised several issues that will hopefully bring improvements to the performance plan and award systems we are now using, improve the training for employees in various areas, and address some of the IT issues that concern many of us.

While successes are important, there will also be challenges that NASCOE will be facing, some known and some not known. Farm Bill implementation, IT issues, and leasing policies are just a few of the issues that we know lay ahead of us. I hope that all members will convey their concerns and ideas they feel are important to NASCOE so they can be addressed. Remember this is your association.

I have enjoyed representing the Midwest Area on the Executive board. I feel the future can very bright for FSA. The farm bill has many things that are favorable to FSA which should help solidify our role in the future. I look forward to seeing many of you at the National Convention in Omaha.

**Steve Abbas,** welcomed everyone, provided opening remarks and introduced out of state guests. Reminded everyone that NAFEC associate membership is only \$20.



Dan Root (past NASCOE Past President): Discussed the following:

- **NASCOE**-Talked about Clyde Payne, one of the founding fathers of NASCOE and why NASCOE was formed. It has evolved into becoming involved in more legislative issues.
- **Farm Bill**-we need to be more proactive legislatively. WTO agreements dictate much of our farm policy. If there are no programs, FSA will not have work. Food, water, metal and power is influenced by energy demands and these are the major factors in the current rising prices. Dan thanked Trice Smith for all her hard when she was the Legislative Chair. The current bill is to expire April 18. No one knows if a new bill will actually get done. NASCOE

is working on Conservation administration. This is important for FSA to administer this program and let NRCS do the technical work. If this is not accomplished in the farm bill, it may be addressed in reorganization. Permanent disaster legislation is very important and we must continue to push the message to congress that FSA needs to administer this program. Crop revenue program will be a new program that is proposed. RMA was designated to be the lead agency for this program, but with a lot of discussion, FSA looks to be the lead agency. Only time will tell when the farm bill is done. Crop Reports: 3 agencies are now taking crop reports and FSA should be the agency that does this. NASCOE is pushing for this and that FSA should administer animal ID program because the GIS system would work very well.

- **FERS Sick Leave** now we get no credit for sick leave. Moran, a congressman from VA, introduced a bill that would give SOME credit for sick leave. A CAPWIZ alert was sent out regarding this issue. The Federal Managers Association and many other employee associations were pushing for sick leave credit.
- **Reorganization**-When farm bill issues were discussed, it was announced that there would be USDA reorganization after the farm bill was done. Bonnie appointed a task force to address reorganization. We need to be proactive on this issue to insure we have a future. Congressman Colin Peterson is committed to reorganization. The task force is not to decide what NASCOE should do, but the members must get their ideas to NASCOE. The NASCOE website has a place to put ideas. When the farm bill was first discussed, FSA was to be the administrative agency for conservation and NACD pulled their support for this after they discovered monies would go to FSA for staffing.
- *Leasing*-A three sentence line was left out giving COC authorities for leasing. Not much else to say about that at this time.
- **NASCOE PAC**-gives us the ability to legally support candidates that support FSA. We have about 120 members donating to the PAC. There is information on the PAC-the money is donated to congress members who support FSA. The PAC makes a difference. Many companies and organizations have PACS.

- **Robert Redding-NASCOE legislative consultant**-has brought NASCOE to a new level with congressional folks. Renewed his contract for a 4 year period. Dan feels Robert is doing a good job for NASCOE.
- Membership and dues-in the 1990's had over 13000 members, now we have around 7700 members. This is due to staffing levels going down. We need active members and we must convey that to more members. The NASCOE officers cannot do the job themselves, so it is important to have active members and we need to get more people involved. The NASCOE board determined that NASCOE needs one year's administrative costs in savings. The cost of doing business is going up. Hotels rooms, transportation, etc is higher each year. The NASCOE Board has done a lot of things to save money. The NASCOE website has been a great aide in saving money. NASCOE is not spending money foolishly. The NASCOE dues are only \$40 and they are the only venue for operating money. We need to have a good discussion on dues. If you want NASCOE to continue to represent you as it is today, dues will have to be examined and probably increased.
- **NAFEC**-The County Committee folks work just as hard for us and they do for themselves. Please become an associate member.

Cindy Pistek-Reorg Task Force-discussed the following:

- Kevin Beekman from MN is also present and could answer questions.
- Congressman Collin Peterson will be looking at reorganization after the farm bill is passed. The Reorg Task Force is to collect information from the membership and present this to the NASCOE board. They want the membership to have input on reorg.



- Three possible situations: *Status Quo*, leaving things the same-*Reassignments of responsibilities and duties*-FSA to be lead agency for many program-*Merger of agencies*, this could affect many areas and agencies. The NASCOE website has Reorg information posted and she encouraged everyone to look at the site and be informed on the progress of the task force. All of the situations must be examined closely and how FSA would be affected. The task force wants members to be involved. It is totally membership driven. The task force is only to relay information to the NASCOE Board.
- Nationwide participation: it is very important that everyone get involved.



**Dee Lehn-MWA Benefits Chairperson**: (Past IASCOE President): Gave a list of websites that have benefits information. She discussed the following:

• **Benefits for members**: Travel Advantage, this is a new project and NASCOE is now working in the black, so this was good news. Have received a royalty check from this. This is not only for NASCOE members, anyone can use it to book travel, but NASCOE gets a % each time it used.

Cell Phone discounts-Alltel, Cingular, Sprint, Nextel, and many

- others offer discounts. The smaller companies do not offer this discount. **NASCOE Attorney**: Members are allowed one hour free with the NASCOE attorney on agency issues.
- *JM Marketing*-Mary Mike Taylor will discuss more details on policies that are available. The cancer policy provides a \$100 refund for wellness screening.
- Whole Health Wellness-Blue Cross Blue Shield offers many different alternative wellness benefits for only \$23/year. Becky Zirpel has been contacting many other health spas to get discounts.
- **Theme Parks**-The process may change this year. With internet access, members can obtain good deals directly with these parks through their own websites. You can go to the NASCOE travel website and book a vacation through that. The committee is looking into how to make this information available to members.
- **Apple**-Government purchasing power. You can order things at a discounted cost to Federal Employees. Please refer to the handout for the websites that you can go to.

#### Tammy Eibey-National CAPWIZ Coordinator: discussed the following-

- CAPWIZ-started as the coordinator after Bob McGrath went to Washington DC. In 2006, over 23000 messages were sent. FSA Tomorrow is a good example of how the system can work.
- Subscription. The 3 year subscription has been renewed for a cost of \$16200.
- Messages: posted 12 items, some information, 10800 messages were sent in 2007. Since Jan-March 21, over 3000 messages have been sent this year. There are over 2000 signed up for CAPWIZ nationwide. There is an alert out there now.
- Iowa-206 subscribed, but only about a third are actually sending messages.
- Volume really makes a difference when sending out messages regarding a subject. There is information available and she can enter information for anyone who would like to sign up for CAPWIZ at this convention.
- IASCOE needs home email addresses to get out information, but they are not shared and they are kept private.

**Joshua Katcher-EJ Brown and Associates**: this Company provides financial information. Handouts were provided to everyone that attended the convention. Discussed FERS benefits and how it impacts you.

**Mary Mike Taylor-JM Marketing**: Discussed policies available to members. Said thank you to everyone for their past support. Long Term Care insurance fits into financial planning. Why Long Term Care Insurance? There is a handout with all the information regarding why you should think about long term care insurance. The average length of stay in a nursing home is 2-3 years. Alzheimer patients generally stay much longer. At some point in time most people will have some type of assistance (home care, etc) and this assistance is very expensive and creates quite a burden on families. The cost of long term care can be \$45000 to \$75000 per year. For a much smaller amount per year, long term care insurance can ease this burden. Why Wait? It gets more expensive to buy the older you get. It is based on the age and health of the person at the time they take the insurance out.

#### **General Assembly Convenes**



Welcome-Steve Kennedy, President IASCOE: Thanked everyone for coming. Was grateful the bad weather hit a day earlier. This is called the "Spring Break" for IASCOE. He introduced the officers, Cindy Mensen, VP, Sue Beemer-Sec/Treasurer. These are the officers for the next year. He also introduced STO personnel and DD's present.

**Charlene Neukomm-Midwest Area Alternate Exec**- She thanked everyone for their support. She discussed the following:

- *Membership*: Midwest Area membership is 85%. Need strong membership to have a strong organization to support our cause and people.
- **CED Classification**: David Vidrine and Randy Cook are NASCOE representatives on this committee. There will be some CED reclassifications. Current CED's will be grandfathered. Criteria: 3 or more full time PT's, have 3 or more major programs, and over 300 program participants. Must have 2 of the 3 criteria to maintain a 12 grade level.



- **PT Classification:** After CED classification is done, the PT reclassification will be examined again. Mark VanHoose is working on this project. They came up with 3 new positions, this is a start to obtain more upgrades. The positions submitted to date are: Assistant CED, Office Operations Coordinators and District Program Assistant.
- **Communication**: we are affected by the Hatch Act and any type of congressional contact must be on your own time and own dime. Cannot solicit membership with the government computer. Communication can be done through Association. The NASCOE website has an update alert available. NASCOE NOW has the latest topics and issues and is a great tool to keep you updated.
- **National Database**: this is a necessary tool to communicate information through. Need home emails and need everyone to sign on or it will not be an effective tool. There are many concerns regarding this, such as security, etc. Hope to have a form ready by June to collect database information. There are many inconsistencies in how states collect membership information at this time. Once the database is in place, it can be of help to the states.
- **Negotiations**: We are very fortunate that we have this process because most agencies do not allow the employees to make suggestions on how programs could be done better. If you have an idea, please submit it. All suggestions are reviewed and then the information are compiled and it is determined if they are negotiation items or program issues. The list is sent to Washington and each item is deliberated on. Example: face to face training. This request has been done by IL each year. If you have a program idea or issue you do not have to wait until fall. The Program Chairperson is in constant communication with the Program Specialists in Washington. If you don't ask, they don't know that you need it or want it. In April, the NASCOE Negotiation Team will meet with the Washington specialists to discuss the negotiation items.
- *Midwest Area Rally*, April 18-19 in Indianapolis, IN. Robert Redding will be there. The Administrator will not be present. She reviewed the convention list. National Convention will be August 5-9 in Omaha, NE. The best human interest story for the Midwest was written by an Iowa member.

#### Brad Murray, Price Support Specialist- Iowa STO-MIDAS/Lean Six Sigma: He discussed the MIDAS program:

MIDAS: Modernize and Innovate the Delivery of Agricultural Systems will transform FSA's delivery of farm program benefits into a 21<sup>st</sup> century business model by developing intranet based self service options. The IBM system 36 programs have to go web based soon. It is hoped that it will improve business processing. He went on to describe the MIDAS project. It is hoped that it will provide the needed future capacity for our customers and our agency. This system will provide the customers the ability to do business with any office at any time. In 2004, CM-493 detailed the MIDAS project. It was picked back up in 2007. The MIDAS team is using the Lean Six Sigma (LSS) system. This system analyzes data and determines the time and processes involved. It is a time study to identify inefficiencies in programs. Pilot counties will be used in the study. Data will be compiled from the study locations and will try to use off the shelf software to improve program delivery. Not sure how this will work, but the analysts insist it will work well. This system has been used by many Fortune 500 companies to improve business practices. Will find "pain points", which is what you don't like about the current system. These points are important to identify areas that need to be improved.



Jim Book, Iowa STO: Discussed Budget. The budget is in good shape. Staffing has remained the same for the past three years. There has been some reduction in permanent workload. It seems that workload and staffing is coming more in line. With a steady ceiling, it enables the state to fill vacancies quickly. There are many COTS in the program, but there are many anticipated CED retirements. The CED vacancies are a priority to be filled. FL vacancies have been filled as well. They have been able to backfill PT vacancies far more timely. There will be no workload reportthis fall. Starting next year there will be a web-based work reporting system. There will be a code for every activity in the office. Not sure what will be in the new farm bill. Rest assured that there will be some new forms and the work that goes along with that. Once the farm bill is finally passed, it will take time to actually get procedure and web applications in place to administer the bill. He closed by saying that FSA was a pretty good place to work.

#### Evening festivities included a dance and the famous Iowa's "Got Talent Contest", an event no one should miss!

**JM Marketing-Mary Mike Taylor**: JM Marketing gave IASCOE a \$100 donation. Mary reviewed some of the programs available such as: long term care, cancer, and life insurance. Please report all changes so that the paperwork can be done properly. The supplemental health plans are not secondary insurance, you submit original bills for compensation.



**EJ Brown & Associates-Joshua Katcher**; They will give one on one presentations on their programs if requested. There is a website you can go to for information.

**Trivia Contest awards were presented.** Hancock County Chicks were in third place, the Ditsy Chicks were in second, and Team Duh won the award with the most points earned. This is a great contest for Iowa members!



**Iowa Corn Growers Association ICGA, Craig Floss, Executive Director**: Thanked everyone for the job they do. Iowa has a check off of 1½ cents. He discussed the following: 93.6 million acres planted to corn with 151.1 bu/acre average yield. Iowa averages 171 bu/acre. People don't understand all the uses of corn and how it impacts us as consumers. Corn Growers are trying to add value to the product that is produced. It is very important to work toward expanding value-added markets for the products in order to get more money for the corn producer. *Anything you make from petroleum can be made from corn*. It's a matter of figuring how to do this economically. Livestock industry is the number one customer for corn. Ethanol is **NOT** the driving force in the corn market. Requests for information on Ethanol have increased dramatically. There are 145 Ethanol plants in operation and 63 under construction/expansion in the country right now. The long term projections are clearly that we will need to produce more econ. The corn growers are pushing for the 10% ethanol blend to be increased. We could produce more ethanol to keep up with increased demands. There are many thing the Iowa corn growers can do to help the Ethanol industry and Mr. Floss outlined many ways. Minnesota has been doing an excellent job of working on this issue. Need to raise the "corn cap" in congress. The Ethanol plants generate over \$13 billion for the country in jobs, tax revenues, etc. Ethanol and Bio-Diesel is the fastest growing industry in the US. All other industries are attacking the corn industry. This is a daily battle with oil and food industries. Less than \$.02 of a

consumer dollar went to agriculture in 2000. Only 10% of our income is spent on food in the US. \$.81 of each food dollar spent goes to packaging, etc, only \$.19 of the food dollar goes back to the farmer. Energy and labor costs are the major factors in the rising food costs. There is a program called Kernels of Truth that informs the public on the actual costs of food. Break even costs are at \$4.05-\$4.15/bu to grow corn. \$5 corn is in the realm of reality with production costs. Mr. Redding emphasized NASCOE needs to be prepared and must be in a position to deal with issued regarding the possibility of organization.

NASCOE President, Bonnie Heinzman (West Virginia), addressed such topics as CED reclassification, PT reclassification, and Performance Work Plans. She also touched on the need for NASCOE to take a pro-active approach to reorganization and encouraged everyone to read over the report prepared by the NASCOE task force which has been posted on the NASCOE website.





Deputy Administrator of DAFO, John Chott spoke to the group on the status of office closures, reorganization, funding COT and FLOT positions, CED and PT reclassifications, the security clearance process, leasing and appropriate use of government equipment. He extensively talked about the current Performance Work Plan system and acknowledged much more training is needed to help development individual standards instead of using the "cookie cutter" approach that is now in place. #### From AAA to FSA

In my office I have a reprint of the front page of The Des Moines Register from November 25, 1933. It is beautifully matted and framed, and the headline reads "Iowan Gets First U.S. Corn Loan." Along with a picture of the historical event, the accompanying article states that the farmer in the picture, W.W. Eral of Pocahontas, will use the \$585 he receives to 'pay a few debts and buy livestock.' This \$585 was the first Ioan under the Agricultural Adjustment Act (AAA) plan to lend farmers 45 cents a bushel for their corn, and signaled the start of a seemingly never-ending chain of Federal farm programs for our nation's farmers.

As I reflect on this framed "snapshot" of agriculture as it was 75 years ago, it speaks volumes of the ever-changing role that Federal farm programs have played in U.S. agriculture. It's amazing when you think about how Federal farm programs and farming have evolved since Franklin D. Roosevelt signed the AAA into law in 1933 and Mr. Eral received that first corn loan.

WWI severely disrupted agriculture in Europe, and this worked to the advantage of farmers in the U.S. who were able to dramatically increase production and export the surplus. By the 1920s, European agriculture had recovered and no longer needed U.S. exports. However, U.S. farmers continued to produce more food than could be consumed or exported and prices began to fall. It was not unusual for a county grain elevator to list corn as minus three cents a bushel – if a farmer wanted to sell them a bushel of corn he had to bring in 3 cents.

The AAA's intent and mission was to restore the purchasing power of U.S farmers to pre-WWI levels by attempting to balance the supply and demand for farm commodities. The law also established county committees of farmers called "Triple A Committees" who oversaw those first Federal farm programs offering loans to farmers, like Mr. Eral. Since the AAA committees were comprised of local farmers, this gave the farmers in each county a much-needed say in how Federal farm programs were administered at the grass-roots level. The government checks began to flow as most farmers couldn't afford not to take the government payments offered through the AAA.

The Supreme Court declared the actions of the AAA unconstitutional in 1936. However, in 1938, regulations were revised and another Agricultural Adjustment Act was passed and with it came new, complicated changes in conservation, crop support and marketing legislation. The 1938 Act also provided for the Ever-Normal Granary, Federal crop insurance and the food stamp program. The Agricultural Marketing Agreement Act (AMA) of 1937 also became part of the AAA, and it sought to establish and maintain orderly marketing conditions for agricultural commodities in interstate commerce and establish parity prices.

After the attack on Pearl Harbor in 1941, the War Food Administration (WFA) was organized to meet the increased needs of a country at war. As wartime posters declared, "Food Will Win the War" and "Sow the Seeds of Victory," government programs were added that supported the expansion of production of all farm commodities. The Ever-Normal Granary reserves that were authorized in the 1938 AAA provided the nation with a vast supply of food, feed and fiber. There was already in place a network of 100,000 farmer-committeemen elected by their neighbors spread throughout the U.S. that worked diligently to inform farmers on the needs and goals for farm products, besides carrying on many emergency activities such as providing help and guidance in avoiding gluts in the marketing of livestock and in getting corn marketed for war industries.

Following WWII, the authority for the WFA was terminated, and in its place came the Production and Marketing Administration (PMA). The PMA maintained a field services branch to aid in program oversight and local county offices to administer the programs. The post-war period of adjustment to peace-time production levels was almost more difficult than gearing up for a war. The PMA was charged with administering the new programs that were established in an attempt to reign in the overproduction that again threatened farm income. Throughout the post-war years, overproduction remained a nagging problem for both farmers and policymakers.

Reorganization in 1953 created the Commodity Stabilization Service (CSS) which oversaw price support and supply management with an emphasis on the preservation of farm income. Conserving programs such as the Soil Bank were introduced to bring production in line with demand by taking land out of production for periods of time ranging up to 10 years.

The CSS became the Agricultural Stabilization and Conservation Service (ASCS) in 1961, and the new name reflected the agency's expanded role in stabilization and resource conservation missions.

In 1994, reorganization resulted in the Consolidated Farm Service Agency (CFSA), renamed the Farm Service Agency (FSA) in November 1995. The new FSA encompassed the ASCS and the farm credit portion of the Farmers Home Administration.

The FSA of today continues to provide U.S. farmers with a safety net through farm commodity programs. There are also disaster programs for both insured and non-insurable crops, livestock programs, dairy programs, and price-support programs. FSA continues the long-standing tradition of conserving the nation's natural resources through the Conservation Reserve Program. The agency provides credit to agricultural producers who are unable to get private, commercial credit, and FSA places special emphasis on providing loans to beginning, minority and women farmers.

From the very beginning of federally administered farm programs in 1933 through the AAA to our present day FSA, the common thread is that policymakers saw, and continue to see, the wisdom and practicality of Federal programs for farmers being administered at the county level. The Federal agencies that administer the farm programs will continue to change, just as farming will continue to change. But something that has always been a constant is the commitment of the local county office staff and county committee to be there for the farmer.

Maybe there's still a Mr. Eral that farms somewhere in Iowa. If so, he probably has been into the county office and is participating in one or more of the programs administered by FSA. There is the real possibility that a check for \$585 issued to him by FSA will be used to pay a 'few debts and buy livestock.'

I haven't found the nerve to tell the hubby we will be having 9 houseguests for several days! I'll cross that bridge when I come to it. For now, I'm just going to enjoy the great grandkids until they are adopted into a loving family and watch in wonder as they grow and develop their own little personalities

# KFFAFS Chapter Day Camp - 2008





#### My Mother's Journey

#### Submitted by Susan Jacobson, PT, Union County

In the fall of 2006, my mother was diagnosed with stage III colon cancer. Soon after she started treatment, the CEA number (cancer cells in the blood) decreased and our family was so hopeful that she was going to be a success story. Then the cancer spread to her liver and a spot was found on her lung – now the cancer was stage IV.

After two disappointing trips to the Mayo Clinic, months of radiation, chemotherapy, and a multitude of tests, my mother died on January 8 of this year. Only one year and two months after her first trip to the doctor and she was gone. She was only 70 years old.

My mother was my best friend and I miss her every day of my life. I didn't know what to do with all my grief and anger - I was afraid it would affect my home life with my two daughters and my work. I needed to find a way to grieve and still function.

I can't bring my mother back, but I thought I could try to help others with this same situation and those trying to deal with the fear and anxiety as my mother did. I have decided to host a 1<sup>st</sup> Annual Jane Jensen Colon Cancer Awareness Walk – the purpose is not to raise money, but simply raise awareness. I first contacted the American Cancer Society who was very helpful in getting me started. I am getting help ordering literature to have available at the walk and an ACS representative will have someone come to the walk so participants can ask questions and get some answers that day.

I am still working out the details, but organizing it has helped me turn my grief and anger into positive energy. The walk is set for September 20<sup>th</sup> and will be held at the Bridgewater Elementary School in Bridgewater, Iowa. There is a walking path around the school and is near my parent's home, so it is a perfect location. The ACS recommends at least 30 minutes of exercise everyday, so prizes will be given depending on how long people walk.

I have learned more than I ever want to know about colon cancer, but the main thing I have learned is that early detection is critical. My goal is to have my entire community and everyone else that I can possibly reach, be aware that a colonoscopy is the only method available for early detection – EVERYONE SHOULD HAVE ONE AT LEAST BY AGE 50 – or earlier if you have symptoms or other family members have suffered from this terrible disease.

I will report back on how the walk goes. In the meantime, think about being proactive with you own health and learn all you can about colon cancer prevention.



of the parking lot that borders the street. She looks like she's walking a tightrope. Her heels haven't touched ground since she stepped off the sidewalk.






