Grade 6 & below \$70.00 -- (only 3.4 cents per hour)
Grade 7-Grade 9 \$90.00 - (only 4.3 cents per hour)
Grade 10 & above \$140.00 -- (only 6.7 cents per hour)

2009 is the 50th Anniversary of NASCOE! Please continue your membership and encourage others to join – for only a few cents per hour, you reap many benefits. Combined with fellow employees across the nation, we work to secure an optimal work environment and continued benefits for all employees.

MIDWEST AREA REPORT June 2009

Things are starting to slow down for me as far as NASCOE activities after a very busy March and April. Five state conventions, the MWA Rally, full legislative conference, and the negotiation session during a seven week period kept me moving. Although it was very time consuming I felt all the conventions, the Area Rally, the legislative conference and negotiation session were very successful and worthwhile.

The Negotiation session was held April 19-23. The NASCOE Executive board, negotiation consultants, and Bill Putnam, National Programs Committee Chair met with members from HRD, DAFO, DAFP, IT, BMPS, and several other departments. We discussed items and concerns raised by the members. We were able to come to some type of resolution on most of the items submitted. Performance plans, the county office reviews, adequate and proper training, and the budget were discussed at length.

NASCOE will continue to focus on these issues and others that NASCOE members feel are important. As issues arise, members are encouraged to submit them to their Area Executive, negotiation consultant, or area programs chair throughout the year. This will allow NASCOE to research the problem and pursue a timely response if needed.

One of the papers we used during the legislative conference addressed FSA's role in the National Animal ID System. Currently, the Secretary has scheduled listening sessions throughout the country in order to get public opinion on animal ID. NASCOE was working to get some producers who support FSA's involvement in the NAIS to attend some of these sessions. If the Secretary schedules more listening sessions in the Midwest we will need to find a good representative to attend one of these sessions.

Doug Caruso was named FSA Administrator and took over the position in early May. During his tenure as SED for WI he developed a great relationship with the field office employees and employee associations. There will be many challenges ahead with ACRE and SURE implementation and the 2009 and 2010 budget shortfalls. I am sure Mr. Caruso will do his best to work with all levels of the agency so FSA can meet these challenges and continue to deliver programs to the American farmer.

NASCOE is celebrating its 50th anniversary in Gatlinburg, TN this August. This should be a great event and I encourage everyone to attend. NASCOE has been working to promote the welfare of its members and American agriculture for 50 years and that is something of which we should all be very proud.

Have a safe and fun summer and I encourage you to take some time for yourself, family, and friends.

Membership has its Benefits

Membership has its benefits. We have heard that statement numerous times over the years and it still holds true as far as NASCOE/IASCOE membership is concerned.

It's an exciting time for IASCOE and NASCOE as it appears we are getting closer to credit for FERS sick leave. The House of Representatives approved legislation on April 1 that would give employees covered by the Federal Employees' Retirement System (FERS) credit for unused sick leave when calculating their retirement benefits. The Federal Retirement Reform Act of 2009 (H.R. 1804), introduced by House Oversight and Government Reform Committee Chairman Edolphus Towns

(D-NY), was approved by a voice vote.

Cell phone discounts, benefits offered through J M Marketing, Theme Park and Travel discounts are already available as NASCOE has worked to secure these benefits and continues to look for other benefit opportunities. Check out www.nascoe.org for more information. Kelly Cain, the State Benefit Chairperson or I (serving as Mid West Area Benefits Chairperson) are also available and willing to assist you with any guestions concerning members' benefits.

Each office should be receiving a letter addressing this year's membership drive. Rising costs and increased expenses has made it necessary for NASCOE to increase annual dues by \$15.00/member. IASCOE had no choice but to follow suit as approximately 15 years have passed since we have raised dues but costs have continually risen over this time period.

Payroll deduction is still an option for IASCOE dues. Because of the change in dues, everyone who chooses payroll deduction will need to complete a new FSA-0444. Payroll deductions and check amounts are:

CO-6 & below: \$2.70 per pay period - \$70.00 per year CO-7 - 9: \$3.47 per pay period - \$90.00 per year CO-10 & above: \$5.39 per pay period - \$140.00 per year

This is a very small amount considering the rewards! For just a few cents a day, each of us can do our part to preserve our current benefits and to pursue new benefit options!

Now, more than ever, IASCOE/NASCOE needs everyone's support. Something as simple as cost of living allowance (COLA) has to be requested for County Office employees after Congress has approved COLA's for other government employees as this is not an automatic benefit for CO employees. IASCOE/NASCOE makes sure that <u>ALL</u> county office employees receive the same benefits. As budget issues and IT issues continue to plague our agency, a strong membership is essential so we as employees can present a united front when addressing such issues with Congress and the Administration.

Iowa's membership is near 90% but we can do better. Let's strive for 100% membership in our state and lead the way for the rest of the nation.



National Legislative Conference 2009

March 16, 2009 - The eve of departure and sleeping soundly I awoke to such a clatter. It was merely 11:30 p.m. and my cell phone was ringing. I could barely understand the caller and did not recognize the voice. The only true words I understood were "NO FLIGHT" The group of 7 was scheduled to leave at 5:30 A.M., verifying the airport website the flight was indeed canceled.

March 17, 2009 - Arriving on time to the airport I learned that some of the troop was boarding a plane to Atlanta. While standing at the ticket counter I met Trice and we discovered the next flight was 4 hours later. The Eastern Iowa Airport is not necessarily the most exciting place to be at 5:30 A.M. or to spend 4 hours, although I did enjoy the time visiting with Trice.

After safely arriving to Washington D.C. and finding the hotel we met with the rest of the Iowa group. It was amazing to see a couple hundred NASCOE members from across the U.S. in a meeting discussing current issues. Each state was going to address the same issues with Congress representatives the next day.

March 18, 2009 - Today was the big day...we were going to "the hill" Our goal was to make a NASCOE presence and discuss the current issues of USDA reorganization and FERS sick leave compensation. Overall, I was very impressed because the Iowa group scheduled appointments with all of the Senators or Representatives. Many of the individuals met with

us directly otherwise a member of their staff took time to meet with us. I was amazed at the effort the representatives took to meet and discuss our issues. Many of them had questions and listened to our concerns. Even though this was my first time on a Legislative conference it was evident that some of our concerns as IASCOE members were also on the radar of our decision makers.

March 19, 2009 - It was time to return back to Iowa. Returning home was no different that going to Washington D.C. There were delays and some of us even fly arrived back in Iowa the next day.


Shortly after our return to Iowa H.R. 1804 (the FERS Sick Leave Bill) was passed by the House of Representatives. The bill passed would give FERS employees full credit of sick leave balances at retirement just like CSRS employees. I believe the Bill was passed by our efforts during the Legislative Conference. The bill still needs to be passed by the Senate and the President before it would become law.

As the FERS sick leave issue continues I encourage you to sign up and utilize CAPWIZ. CAPWIZ is very simple to use! You will receive an email when there is a current issues to address. You simply log into CAPWIZ enter your contact information and can submit a letter or email to your designated Congress officials. You may also modify the existing letter if you desire. The entire process takes less than a few minutes but could have a huge impact on your career with FSA. Please use your personal email address and computer when using CAPWIZ. If you do not have a computer many times your local library offers internet access. The more concerns a Congress official hears from their constituents the more likely they are to address the issue.

HOLLYWOOD COMES TO DENISON

Every year in the month of June, the west central Iowa town of Denison honors the life work of hometown celebrity Donna Reed. Best known for her roles in movies *It's a Wonderful Life* and *From Here to* Eternity, and the televised *The Donna Reed Show*, this Hollywood film star's career spanned 3 decades in the 1940s, 50s and 60s.

Donna Reed left her home near Denison at age 16 for educational opportunities in Los Angeles. Her successful acting career came from hard work, ambition, vision and values. Behind the cameras, she was the un-credited producer and director of *The Donna Reed Show*, studying and mastering both lighting and cinematography – roles rarely handled by women of that time. It was her value of knowledge, experience, and education that inspired the creation of the Donna Reed Foundation, an organization dedicated to keeping the dreams of students in the performing arts alive.

After Donna Reed passed away in 1986, the Donna Reed Festival of Performing Arts was created in 1987 as a small film tribute and has grown into a full-fledged festival of student workshops led by industry professionals. Workshops include theater performance, children's musical theater, methods of theater arts coaching, and private coaching. Devoted and talented students are eligible to win thousands of dollars in scholarships and merit awards. Various events are scheduled throughout the week to provide students the opportunity to showcase their talents to the public, and scheduled family activities involve the public in the festivities. The Donna Reed Festival is a great way for aspiring performers, musicians, film writers and instructors of all ages to explore entertainment careers without leaving the comforts of Iowa. 
HOBO CONVENTION

What are you doing on August 6th through the 9th? Do you need a unique, inexpensive trip? How about Hobo Days in Britt, Iowa? Yes, this is all about the Hobo. A Hobo traveled from place to place catching a ride on the rails doing odd jobs along the way. There really are true "Hobos" and they come to Britt every year for a weekend stay (many stay for a couple weeks).

The Hobos come to Britt and put up their tents in what has come to be known as the "Hobo Jungle". This is a nice grass area with a shelter house sitting right next to the railroad tracks that come into town. On Thursday night they light the bonfire and community members and visitors bring their lawn chairs to enjoy the singing, dancing and stories of the Hobos. Every evening the bonfire burns welcoming anyone who wishes to enjoy the free entertainment.

Throughout the whole weekend you can visit with the Hobos on main-street as they spend time with the people. On Saturday we have a large parade and a free Mulligan Stew feed in the park. The stew is full of vegetables, tomatoes and barley. It is cooked in large vats outside and stirred with large metal paddles. After the parade people bring their pots or plastic buckets and we fill up their containers so they can feed whoever might be with them. In the afternoon the crowd crowns the new Hobo King and Queen after hearing each Hobo speak. On Saturday night you can go to the Hobo Jungle where the new King and Queen (and the other Hobos) will once again entertain you with their songs and stories. Bring your lawn chair! Sunday you can see a great car-show on main-street. During the weekend you can enjoy a carnival, great food, a flea-market and check out the Hobo Museum. Camping sites are available (with hook-up) are located at the Fair Grounds in Britt and at Crystal Lake (only 6 miles north of Britt). Take a trip to North-central Iowa for some small-town hospitality and fun.

We walked through the other barns and watched the feeding process which we found very interesting. The barns are partially open and the cows do not leave their pens except to milk. We also learned that a cow makes milk lying down. They want the cows to eat and rest to make that milk.

By the time we finished our tour it was almost dark and we were treated to a delicious meal prepared by Greg and Julie at their home. It was a perfect end to a fun day. I think that Dan had almost as much fun as I did!!!!

RECIPES FOR SPRING

Spring fruits and vegetables are in abundance this time of year. Rhubarb and asparagus are two of my favorites.

Grilled Asparagus Medley

1 pound fresh asparagus

1 each sweet red, yellow and green pepper, julienned

1 cup sliced fresh mushrooms

1 medium tomato, chopped

1 medium onion, sliced

1 can (2-1/4 oz) sliced ripe olives (drained)

2 minced garlic cloves

2 tablespoons olive oil

1 tsp minced parsley

½ tsp salt

½ tsp pepper

½ tsp lemon-pepper seasoning

½ tsp dillweed

In a disposable foil pan, combine the vegetables, olives and garlic; drizzle with oil and toss to coat. Sprinkle with parsley, salt, pepper, lemon-pepper and dill; toss to coat. Grill, covered, over indirect medium heat for 20-25 minutes or until vegetables are crop-tender, stirring occasionally.

Diabetic Exchange - 1 vegetable, 1 fat

One $\frac{3}{4}$ cup equals 78 calories.

Rhubarb- Nothing is better than ruby red rhubarb served warm over vanilla ice cream!

Rhubarb Jam - Charlene Hoffman - PT Union Co

3 C rhubarb, cut into small pieces 2 1/2 C sugar
1/2 C water 1(30z) box dry jello - use peach, raspberry or strawberry

Cook rhubarb, sugar, and water until done. Remove from heat. Stir in dry jello. Put in small jars and refrigerate.

Rubarb Muffins - Barb Roberts - PT Adams Co

2/3 C oleo 11/2 C brown sugar 1 C buttermilk 1 egg 2 1/2 C flour 1 tsp soda 1 1/2 C diced rhubarb 1 tsp vanilla 1/2 to 3/4 C nuts, chopped cinnamon sugar

Cream oleo and sugar together, add egg and beat well. Mix the dry ingredients together and add alternately with the buttermilk, beating until smooth after each addition. Add the rhubarb, vanilla and nuts. Pour in greased or paper cup lined muffin tins. Sprinkle the top with cinnamon sugar. Bake @ 350 for 15 to 30 minutes (depending on the size of the muffin)

Asparagus Salad - Charlene Hoffman - PT Union Co

- 3 T vegetable broth
- 3 T white wine vinegar
- 1 pound thin asparagas, trimmed and peeled
- 3 T chopped chives
- 3 T Parmeson cheese

Bring broth and vinegar to a rolling boil in large skillet. Place asparagus in boiling broth mixture, and cook 5-6 min. or until tender-crisp. While asparagus cooks, fill a large bowl half full with ice, then add enough cold water to come up to top of ice. When asparagus spears are cooked, remove and immediately submerge in ice bath to cool completely. Drain and remove ice then sprinkle with chives and cheese. Add pepper to taste. Chill and serve.

SIMPLE SOLUTIONS

In an effort to curb spending, here are some "hints" that are economical and work well.

- ** These days my house is full of those pesky flies that seem to come out of the wood work as they wake up to spring. Saturate a sponge with oil of lavender and place it in a shallow dish or pan. Put one in each room and pesky flies will disappear.
- **This is a window cleaner I tried last spring and it was great! Mix 1 half cup of ammonia with 1 half cup of white vinegar and 2 tablespoons of cornstarch in a bucket of warm water. Automobile grease responds well to butter, followed by regular wash and rinse.
