















#### A Message from our State Executive Director

#### **National Legislative Conference 2011**

On March 7-10, seven IASCOE members were part of this year's delegation at the 2011 National Legislative Conference in Washington, D.C. For the three of us writing this article, it was our first time attending the National Legislative Conference. As we traveled from Iowa we thought about the employees and producers that we were going to represent. We were in for a huge task, but one we were ready to handle. All of us but Tammy Eibey had the same flights and we made it to D.C. without any troubles or delays. However, our shuttle ride to the hotel was a different story. The van was weaving in and out of traffic, slamming on the brake one second, and then pedal to the floor the next. Somehow we managed to get to the hotel unscathed and ready for an evening of relaxation and networking opportunities with fellow FSA employees from all over the nation.

On Tuesday, March 8<sup>th</sup>, the NASCOE 200+ delegates, in whom about half were new attendees, met to go over the position papers and learn how to make effective congressional visits. NASCOE leaders prepared the attendees and helped us to devise our plan. The message was pretty clear; "BUDGET" and our organization wants and needs to be assertive and instrumental in helping and educating Congress so that they can make sound decisions that impact our future. We also had the opportunity to listen to several great informational speakers. These included Robert Redding, NASCOE Legislative Consultant and Congressman Stephen Fincher, member of the House Ag Committee. Presentations were also made by MIDAS, NASCOE PAC, RASCOE, and NAFEC.

Congressional visits were made on Wednesday and appointments were set up to meet with all of Iowa's five Representatives and two Senators. We were able to meet with the majority of the congressman in person, and for the others we met with their aides. All visits were about 30 minutes long and everyone seemed interested in the issues we presented. The message was simple and an easy one for the congressmen and women to accept. All of them expressed that they are looking for ways to cut spending and we discussed some ideas regarding removing the duplication of services between agencies which would do that. FSA and its employees operate on the smallest margin and have a proven track record of providing services that can and are used by other USDA agencies. At the end of the day, we feel like our team accomplished our goals and informed our Nation's leaders of the effectiveness and importance of county offices.

After our day on the Hill, we had Wednesday night free and five of us decided to take a 3.5 hour bus tour of the city. We were able to see many of the major landmarks and monuments in D.C. and had 15-40 minutes at most to walk around and take pictures. Everyone really enjoyed the tour, especially those of us who had never been to D.C. before.

This was a great opportunity for us. One of the best ways that we have heard NASCOE described is, "From the outside looking in you can't understand it and from the inside looking out you can't explain it." We truly appreciate the opportunity to represent Iowa at the National Legislative Conference. The IASCOE leaders are looking to get more first-time delegates at future legislative conferences, so please let them know if you are interested. We encourage all employees to join their State Association, sign up for CAPWIZ, and become a PAC contributor. #### **IASCOE** Membership is Vital to Your Job

We all know that becoming a member of IASCOE is elective and is a personal decision. This is still true to this day. If you have elected to not become an IASCOE member for whatever reason, I would just like to share with you that now, more than ever, with the very serious budget cuts that FSA is facing that your decision in becoming an IASCOE member could save your job and the job of your co-workers. If the dues may be a reason for not enrolling, please remember that there are many IASCOE benefits out there, from cell phone discounts to Sam's Club memberships, theme park tickets, and many more that easily cover the cost of the annual dues for IASCOE. You can choose to have your membership dues done through automatic payroll deduction for only a few dollars a pay period. For those that have been an IASCOE member I wish to thank you for your support, and hope you elect to continue your commitment to the IASCOE mission. Now let's go on to explore what is at stake for all FSA employees if we cannot get representatives on the ground in our State and Washington to fight for our jobs, benefits, and the services we provide.

Have you been reading, discussing, and begun implementing any of the recent information on what cost saving measures that we are encouraged to undertake just in our local offices? I have, and it is frightening to know that many of these measures depreciate our standard of service to our customers and yet, are necessary to keep us employed. In reading some of the cost savings measures you could say to yourself, how are these going to help? These "currently" requested cost savings measures, at this point in time, are being implemented in part to help divert monies from those areas we are cutting back on to help pay our wages and benefits. How can we be expected to maintain our high sense of public service from FSA if we do not provide the most basic services to our customers and keep them coming through the door in order that we can be employed. Some may say, well in this age of our computer driven society we don't need to provide copies of documents to a producer and they should get online to do self service measures. This is self destructive to FSA's existence and we are nowhere near the level of customer's access nor proficiency in the computer world to go even consider this route at this time and not affect our customer's view of the services we have been providing and their need for our services if we cannot provide them how they want or need them. What will keep them coming through the door? What will then keep us on the job?

In summary if we are unable to get adequate representation out there to present our ideas, thoughts, views, and spread our words of the necessity of our agency's services that keeps us employed we will surely realize undesired results. Our IASCOE representation has not equaled that of other agencies for a long time and some of those agencies have not realized the cuts as severely because of their ability to represent their employees through their high numbers in membership. Our recent loss of two years of COLA's was in part due to our inability to effectively represent our need for funds, and there is a proposal to extend that COLA loss for another five years. What benefits or jobs are next? If FSA is unable to represent its ability to effectively and efficiently provide the programs and services we currently offer and lose them to other agencies it would prove to be disastrous to FSA.

I welcome all FSA employee's comments and suggestions, either positive or negative, regarding IASCOE membership so that we can research how we can enhance IASCOE membership to encourage enrollment. What will it take to bring IASCOE to 100% membership? I know we are a "can do" agency, so let's do it here in Iowa!

#### Are You Prepared To Make Change Happen!!

Have you found your office subject to a COR review recently? Has the reviewer documented an improper payment because procedure dictates the program one way and practicality calls for a different approach? Well here is your chance – *make change happen* and submit a recommendation through NASCOE Programs committee to avoid future improper payments. The **NASCOE Program Efficiency Submission Form** has been included in this newsletter and is available on the NASCOE website. So get your recommendation ready to submit today!

Your suggestions do not have to go through me. I want to ensure Iowa's ideas reach NASCOE Programs Chair for consideration. I am all for improving the FSA environment and making our work lives a little less complicated. Here is a bit of help in order for you come up with a fantastic idea: Programs items may include difficulties you encounter in your daily activities that cause problems for you and/or our customers. I encourage you to provide a solution to make things easier, faster or perhaps to increase FSA customer satisfaction.

Earlier this month I received a copy of a Program Efficiency Submission from the Kansas Programs Chair, expressing a concern about 6-CP procedure on completing AD-1026 for Revocable Trusts. He was wondering if Iowa CORs had found similar errors with Revocable Trust's AD-1026? Across Kansas, county offices are being written up for listing the name of the Revocable Trust (using grantor's SSN) at the top of the form. Whereas procedure found in par. 401E, states the grantor and/or beneficiaries are to complete the AD-1026, not the Trust. Then when comes time to load data into Subsidiary, the grantor's 1026 information is under the SSN which FSA software lists as the Revocable Trust. So we are doing a form that does not match the software...and Kansas has shared their immediate concern through the NASCOE programs committee to make change happen!



## Food Memoirs of a Traveling COT Pat Derdzinski

One benefit of being a COT is the cuisine experiences we encounter in numerous towns across Iowa. I must profess I am not a corresponding culinary expert as Guy Fieri (Diners, Drive-ins and Dives). But residing in a hotel for several weeks in one location will broaden anyone's search for gastronomic excellence.

As such, when stationed in Humboldt City, I was referred to a local, favorite food establishment in the Humboldt County seat of Dakota City. It is called Vinny's BBQ, located at 507 Main St., Dakota City, just south of Hwy 3 east of Humboldt City. The restaurant owner is Gary Vinsand, a former John Deere mechanic. Gary had a hobby of experimenting with ribs and sauces and had entered numerous contests. His love of BBQ eventually led to opening Vinny's BBQ. The restaurant serves lunch and supper every day.

But if you ever travel through Dakota City (right next to Humboldt City), on a Thursday, you cannot miss their Thursday rib tip special. You can order your choice of sauces which includes a hot BBQ sauce and of course, their own house special. Portions are ample and the prices are very reasonable.

Vinny's BBQ also gained notoriety for cooking the Guinness world record pork burger. The patty was 42 inches across by 10 inches deep and used 240 lbs. of pork. Little Chicago Pizza and Gyros - location 11 2nd St, Mason City - I have only had the pizza. It is a thin crust pizza that is out of this world. If you are in a hurry or are seeking a nice "atmosphere" it probably isn't the place to go, but excellent pizza. We usually do the carry out.

Pastime Gardens - location 404 S Madison Ave, Mason City - Excellent Mexican food. The building is extremely tiny, and the hours it is open are limited, but the food is excellent. I think they are only open Tuesday and Thursday during the evening and only during the day on Saturday.

Bill's Bar-B-Q - location 215 S Madison Ave, Mason City - Only one selection either with the dinner or without, but very good if you like BBQ.

Sum Hing Chinese Restaurant - location 247 N Clark St, Forest City - excellent Chinese food. If I can find a reason to go to Forest City we will typically eat here.

The Hungry Mind - 16 S Commercial Alley, Mason City - I usually get the gourmet burgers. The restaurant really brings back good times from my youth more than anything. Very good gourmet burgers.

PM Park is one of the only two eating establishments left on Clear Lake's shoreline in north central Iowa. It is a restaurant along with a small summer retreat located off South Shore Drive next to Clear Lake Boats. It is one of our favorite places go on our motorcycle.


The restaurant is a step back in time. The front dining rooms overlooks the lake while the main dining room is one large room with a laid back casual summer atmosphere. Every wall has pictures featuring the history of Clear Lake and PM Park. The second floor of the building is used as a party room for wedding receptions or reunions. There are also tables for outside seating to enjoy summer by the lake. A lakeside Tiki Bar has been added serving beverages until midnight and on special occasions live music. Wedding celebrations are common every weekend there as a gazebo built on the large lawn is a perfect setting for a summer outdoor wedding.

The PM in the name stands for Patriarchs Militant. In the 18<sup>th</sup> century, this was the name given to the people left behind when war broke out to take care of the children, orphans, women, and elderly. They are a uniformed branch of the Independent order of Odd Fellows (I.O.O.F.). In the 19<sup>th</sup> century, orphanages were common so they set up 'PM Parks' to take care of the widows and orphans. At one point in time, every state in America had one or more PM Park. The Clear Lake PM Park is one of the few left. It was established in 1914 and still to this day it is owned by the Patriarchs Militant. They lease the facilities to Rahn and Cris Brager to run the restaurant and lodging facilities. At least once a year, the Patriarchs Militant make their way to the park for a week at a time holding meetings, ceremonies and various events usually in July.

The main building that was once used for a gathering place for eating and entertainment for the children's camp is being used as the restaurant. The second original building that was once the dormitory is still being used for lodging. The rooms have been modified and somewhat updated to accommodate individuals not just a group of children. There are also short term apartments available just up the road as well as a cottage for summer rental to enjoy the summer lake vacation experience.

PM Park is open from mid May to mid September seven days a week for breakfast, lunch, and dinner. Sunday morning features a brunch or you can order off the menu but you won't go away hungry or disappointed. Watch for two large bluish-purple buildings as you cruise Clear Lake whether it is by boat, car or motorcycle and stop in for some food, drink, and relaxation. #### Local places for wine and Beer



Bel-Aire Estates is a small winery in North Iowa that focuses on selling quality wines made from local produce. Located two miles west of St. Ansgar, Iowa, just off Highway 105, the owners, Steve and Lorraine Beland moved to the area in 1992, planted an orchard over the next three years and the vineyard in 2001. The company was started with co-owner Adam Strouf and awarded its winery license in 2006. They produced their first bottle of wine for sale in the spring of 2007.

They currently have 350 apple trees and an acre of grapes. They pick all of their grapes and apples, ferment and bottle everything on site. With over 3 acres of fruit grown on site, the vintners at the winery have created multiple varietals to suit a wide variety of palates. Currently available are 4 grape wines ranging from dry to sweet, 4 apple wines, rhubarb and watermelon. The wine is sold locally and also at both Mason City Hy-Vee stores. They also have jams, jellies, and apple butter which are sold on site. An apple fest is hosted each fall.

They invite you to stop by any time during winery hours to taste their wine as well as pet their three signature donkeys. Current hours are Tuesday through Friday from 2 pm to 8 pm and weekends 12 pm to 8 pm. Many people also enjoy their 4 fainting goats (two of them twins born on April 6<sup>th</sup>) and two pot bellied pigs plus two dogs and three cats. During warm weather months they are also open late for viewing of their popular outdoor movies.

#### **Eagle City Winery**

Looking for something to do? Want to see some picturesque scenery in Iowa? How about taste testing some wine made in Iowa?

Nestled in the Iowa river Greenbelt area between Iowa Falls and Ackley in NE Hardin County is the Eagle City Winery. Eagle City was the first settlement in Hardin County on the banks of the Iowa River. Settled in 1850 by Jacob Kidwiler, a mill was built and early settlers would have grain ground at the mill. By 1883, Eagle City consisted of one store, one blacksmith shop, one gristmill, six houses and a post office. Eagle City vanished over time.

In 1991, Dr Ken Groninga and his wife, Carolyn, purchased an acreage on the site of Eagle City. Dr Ken practiced veterinary medicine for over 30 years, primarily in NW Iowa. Dr Ken originally grew up in the Ackley area and wanted to return to his roots. There are a lot of various wild fruits and berries in the area so Dr Ken started experimenting with wine making using the fruits and berries around their acreage. He started entering wine competitions and even had the Best of Show for a non-grape wine at the 1998 Iowa State Fair. Ken enjoyed making wine and he and Carolyn decided they would try opening a small winery on their acreage. They both thought that is something they could enjoy in their retirement. They started a small vineyard and constructed a winery. They started selling their wine, both retail and wholesale, in late 2000.

The winery is open 10:00 AM to 5:00 PM daily except Mondays. They are also open from 1:00 PM to 5:00 PM on Sundays. Each Spring and Fall they have an open house which attracts a large number of people over a Saturday and Sunday weekend. The Spring Open House this year is slated for June 4 and 5. The open house runs from 1:00 PM to 5:00 pm each of the two days. This is the opportunity for guests to sample the great wines that Dr Ken makes. The open house also features Hors d'Ouevres, a live band, and even donkey cart rides.

Currently, Dr. Ken makes 17 different wines. They include: Eagle City Red, Merlot, Cabernet Sauvignon, Chardonnay, Riesling, Riesling Reserve, Cranberry, Rhubarb, Red Altar, Apple, Concord, American Golden Riesling, Raspberry, Edelweiss, Ruby, Black Currant, and Sweet Riesling. Dr Ken has told me that Rhubarb is his best selling wine. Personally, I love the newest addition which is Black Currant. He has everything from dry red's to very sweet desert wines. If you venture to the winery, you will find the scenery in the area to beautiful. However, the roads wind all over. Ask me, I have been lost on several occasions in this area. Dr Ken has provided GPS coordinates on his website. The coordinates are N 42 degrees, 28.191 and W 093 degrees, 08.908. There is also a map on the website. As I walked through sampling the "goods" my eyes focused on a bottle of something I had only heard of but was never able to get my hands on. In fact, my husband had been on a waiting list for months now for "the good stuff". I was in shock as I stood there staring at the bottle in front of me... Templeton Rye. I lunged at it grabbing the last bottle off the shelf. The ladies with me laughed as they saw me weed through the crowd to get it. "What's so special about this stuff", one of them asked? It's Templeton Rye! I said. "So", one of them said. "You don't get it, this stuff is rare! Many are on waiting lists to get one bottle! My husband will fall in love with me all over again if I get this for him," I said.

I brought it home and he was indeed in shock that I had found this bottle of "The Good Stuff" that he had been on a waiting list to get.

I did some research on this coveted bottle of whiskey and found that it has quite an interesting history. Templeton Rye is so named for the town it was created in. Templeton is a small little town in western lowa that was struggling with the rest of the country during World War I. In 1920 bootlegging began to appear in Templeton and this whiskey was on the top of the list. It was created from corn in the early days but later the famous rye whiskey was commonly produced. It has even been noted to be a favorite of Al Capone's!

This whiskey is much too strong for my taste, even with adding Diet Coke, but my husband loves its smooth quality! You're even able to take tours through The Templeton Rye Distillery which is located at 209 East 3rd Street in Templeton, Iowa. You'll want to call for reservations to find a time in which they do their tours or check out their website at Templetonrye.com. We are planning a tour with some of our friends this summer and can't wait!


