One big way to make sure that you are up on everything that is going on is to sign up for CapWiz from your home computer. You need a home email and home computer (or even a smart phone can do the trick). Our leadership follows the happenings of a bills that may be passed or things that may be happening with the Farm Bill and we may need to contact Congressmen or Senators to give them our point of view. Everyone has a stake in our future; whether you are just starting your career or just about ready to retire. You can receive alerts on many different things but the ones that come from CapWiz are the ones that our leadership feels are of great importance and they feel that you need to make some contacts. It is an easy process and if you have signed up for Capwiz all you need to do is send your first letters by email and after that it takes only a few seconds to send a letter. Easy to do and it is really something that you should do to help secure your future if you have a number of years left with the agency or if you are ready to retire. Some of the topics for the alerts deal with you and your retirement. It is time for you to get involved. The same can be said for some of the alerts coming from National Association of Retired Federal Employees (NARFE), because we have teamed up with them to get the word out. Please send out a letter if you get the alert. If you believe you never receive the alerts (and are signed up for CapWiz) check your junk-email because your computer may be set to trash anything with more than just a few email recipients. If you have any questions please give me a call.

If you ever have any questions about what the agency or association is doing please feel free to contact either myself or a director to get their point of view on the situation. One thing to remember is that IASCOE/NASCOE is looking out for all of the FSA employees from California to Maine and Washington to Florida. If you want to know something, just ask- there is no such thing as a dumb question.

There is no time like the present to get involved and with the dwindling number of employees every person counts. Get your co-worker or someone from your neighboring county involved. We all have to be involved to make our future brighter.

Well, it appears that maybe warmer weather might be here to stay?? I absolutely love spring and summer, so bring it on! The past few months we have all seen changes and heard much about the challenges ahead. We are a resilient group of individuals and are used to the "moving target" as it were, but now we need to be fully informed and proactive. The IASCOE Convention was a great success and we were fortunate to hear from many of those individuals closely involved with NASCOE. We heard from Mark VanHoose (NASCOE Vice-President), Dan Root (National Legislative Co-Chair), Tony Augustine (MWA Legislative) and Charlene Neukomm (MWA Executive). We are very fortunate to have some good representation from the mid-west as we work through the budget crisis and the new Farm Bill. As you read through this newsletter, I think you will find some informative articles from some of these individuals.

Last summer I joined NARFE (National Active and Retired Federal Employees); it is not only for the retired it is for the employed as well. Each month I get a magazine keeping me posted on what is going on in DC and what will/could affect the federal employee. I also receive e-mail alerts, (much like Cap Wiz) so I get plenty of new information. The May issue's cover said "Can We Stop the Congressional Steamroller?" That certainly got my attention and I opened it up for a very interesting read. Here are some VERY BRIEF notes about the "Steamroller" and what it could mean for us as employees.

- Retirement Security- Bills are proposed that would either reduce or eliminate the FERS annuity or require employees to pay more toward retirement, or both
- Health Care Bills are proposed that would require Medicare enrollees to enroll in the FEHB Program and slowly phases out Medicare (a sure way to increase premiums). Another proposal would be to increase the share of health insurance premiums paid by the employee, retiree or survivor.
- Federal Pay Proposals to extend the current two-year pay freeze for up to five years total (through 2015).
- Workforce Reduction Place a greater workload on federal employees by arbitrarily reducing the size of the workforce, unattached to program cuts

So far this year, Congress has passed only one piece of legislation affecting the federal family-increasing retirement contributions for newly hired federal employees, says NARFE. I ask you-can we afford to take a "wait and see" attitude?? I believe that we all need our benefits and enjoy the security they provide for us and our families. I urge each of you (active and retired employees) to be diligent in paying attention to what is proposed in Congress and how it affects us all. A steamroller can't be stopped by watching it head our direction and hope it doesn't run us over! Things like Cap Wiz, NASCOE, NAFEC (National Association Farmer Elected Committee) and NARFE are just a few of the tools we have to stop this steamroller from hitting us head-on. Comments From the NASCOE Vice President

This is one of our most challenging times in the history of NASCOE. We have hit the perfect storm of extreme high commodity prices and severe Congressional budget restraints. So our highest priority has been making sure that FSA has a prominent role in the new Farm Bill being considered in Congress. Since we announced the results of the Informa study and the savings available by involving FSA in crop insurance processes, we have been criticized by the crop insurance industry and others at every turn. But it is interesting that no one has questioned the savings projected in the report. After the initial negative backlash I think the response continues to turn more positive and I commend the leadership that initiated this study over a year ago.

I have a good feeling concerning our legislative approach but it takes all of us to get it done. It is very important to participate in our CAPWIZ alerts and also the PAC. Build relationships with your Congressional folks as well so they have a good understanding of the importance of FSA as part of the Farm Safety Net. Also take time to build strong relationships with leaders in your state farm organizations. This can result in benefits as we work to remain a vital agency.

Some points I made in my speech to those attending the Midwest Area Rally:

- Food is a national security issue. And FSA is part of the equation for maintaining a safe, cheap food supply.
- Get your state's NAFEC group stronger by building membership. Find a way to bring a NAFEC member from your state to national convention. NAFEC is an important part of communicating the FSA story of service to agriculture!
- NASCOE offers one free hour to members with the NASCOE attorney when an unfair personnel issue arises.
- County committee meeting time is a big issue for us. Returning leasing to the county office is a big issue. PT classification is a big issue. Measurement service money not coming back to the county office is a big issue. Difficult to work on all these issues when we are fighting to save FSA and our jobs.
- Every Secretary wants to centralize services and reduce the number of county offices. Producers doing business on line will always be a priority of every administration. But we know that producers will not embrace this process and so we continue to educate Congress on this issue.
- We are striving to make sure reasonable office closure language is enacted to make sure county offices stay open to service the public.
- Make sure you are signed up to receive NARFE alerts on issues that affect your benefits. Employee benefits are under attack like never before.

Remember that NASCOE is your organization and doesn't work unless you are involved! Your participation is especially important in the legislative arena. Take time to look at the tools available to you on the website. This organization can accomplish anything it sets out to do when membership is engaged and working!

Thank you for the support of the Iowa delegation and it is an honor to serve as your NASCOE Vice President.

MWA CONVENTION NOTES

Several of us traveled to the MWA Rally in St. Louis, MO. The convention was a two day event with Friday being the Missouri Convention and Saturday being the MWA Rally. We heard from several individuals including Mike Wooden (Deputy Admin Field Operations). Normally, when you have a guest speaker they stand at the podium and give you their "speech". Mr. Wooden grabbed a chair, pulled it towards us and sat down to have a chat, including giving us an opportunity to ask questions or make suggestions – what a refreshing change in format! He proceeded to tell us that he is an original FSA employee who went through the ranks (COT, CED, DD, and SED) and has been in DC for the last 3 years. Periodically, Mr. Wooden travels to an area FSA Office (at his own expense) so he can keep in touch with what's going on at the local level. Mr. Wooden gave us some information about MIDAS and that January 2013 is the target for the deployment of acreage reporting. The next deployment is slated for April 2013 (Marketing Loans)-all of this will call for training. The plan is to prepare approximately 450 national trainers who will then train the states and counties.

Mr. Wooden also told us that in the period of March/April 38,000 new e-mails have been brought into the system. I know that in our county, much of that is our way of trying to do as much business as is practical by e-mail due to budget concerns. Fortunately, Mike understands that we need to find creative ways to reach out to those who do not have access to e-mail. Mr. Wooden also addressed; extending the Key PT positions another year and evaluating the potential for this to be a permanent position, COT training must include both FP and FLP, Gov-Delivery, VTC System (each STO has one, one SED has even conducted interviews by this system) and cross-training.

When it came our turn to ask him questions...

- FSA Offices slated to close yet the NRCS office in same location remains open? We have no control over what NRCS does, but NRCS is asking for a plan by September so they are having to deal with issues as well
- COC system where does that fall in the scheme of things? The system is alive and well according to DC. The administrator believes in the COC process and it has his support
- ARS System? Wooden worked under our old workload system and understands our frustration with this new method. The belief is that the ARS system will become more effective in time.
- CRP letters from KCMO, can we stop those coming from KCMO and put it back to the county office? At the least, could we review the list of those to be sent out? Those letters go out based on an old mailing list and many times get returned to the county office with a postage cost for an address change. Mr. Wooden was going to take this suggestion back with him and see if anything could be done.

It was a very good discussion and I was pleasantly surprised by his candor and genuine concern for the employees and the customers we serve.

2012 Destination: The Iowa State Fair!

There is No Better Time than 2012 to Visit the Iowa State Fair as it's also USDA's 150th Anniversary Celebration!!!

The Iowa State Fair is one of the top and single largest events in the country. The Iowa State Fair is included in the travel book, "1000 Places to See Before You Die"! The fair grounds are 445 acres of which 160 of those acres hold 30,000 campers. There are 700 exhibitors and concessionaires nearly 200 of them are food stands, 300 exhibitors and 200 merchandise booths.

The fair educates, informs and entertains people from all walks of life. Whatever your interests are you are sure to find it at the Iowa State Fair whether it be agriculture (the fair has one of the world's largest livestock shows), the arts, entertainment, people mingling and watching, food (more than 50 of them on a stick), rides and on and on. In 2011 there were 1,080,959 fairgoers.

The Iowa State Fair is located in Des Moines at East 30th and East University Ave, where it has been located since 1886. The Iowa State Fair was named to the National Register of Historic Places in 1987, as most of the buildings pre-date World War I. The Iowa State Fair has only been cancelled five times in history and that was in 1898 when Omaha hosted the World's Fair along with the Spanish American War and also in 1942 – 1945, the years of WWII. The first Butter Cow was sculpted in 1911, Bill Riley's talent search debuted in 1959 and the 1st State Fair Queen Pageant was held in 1964. The famous novel "State Fair" written by Iowan Phil Stong was about the Iowa State Fair. Phil Stong was Norma "Duffy" Lyon's uncle. Duffy resided in Toledo, Iowa, and began sculpting butter in 1960 at the Iowa State Fair as the first woman and fourth sculptor.

The Iowa State Fair dates for 2012 are Thursday Aug. 9th – Sunday Aug. 19th. The Parade is held on Wednesday August 8th at 6:15pm downtown Des Moines, West on Grand to 13th Street with approximately 200 entries. The hours for the grounds are 7am to 1am, the buildings are 9am to 9pm and the midway is 10am to midnight. Admission costs are \$10 (adult), \$4 (children 6 - 11) and children 5 and under are free. You can purchase discounted admission tickets from July 1st – August 8th at Hy-Vee, Hy-Vee Drugstore, Dahl's Foods and Fareway Stores \$7 (adults) and \$3 (children 6 – 11). Grandstand entertainment costs, parking and horse shows are in addition to the gate admission costs. The Grandstand Concerts and Events are from a variety of venues (they are listed online now). In addition there are many free stage lineups which will be announced in late May. The daily programs will be posted in early July. The Des Moines Register will have an insert on Sunday August 5th of the daily events or you can visit <u>www.iowastatefair.org</u> for the details.


