State Convention/MWA Rally Updates:

- Finalize registration fees: We missed a couple of things at the face-to-face meeting. There will be a Thursday IASCOE Convention one day registration fee. It will be \$10 if you are only attending the meeting, which would include meeting materials, morning coffee, possible afternoon break snack and the chair you are sitting in. FLP folks would be required to pay the fee as well. Those who wish to stay for the evening activity would pay an additional \$10. The MWA would start on Friday and be a half day on Saturday as well. \$45 is the registration fee for the rally, which will include breakfast on Friday morning and taco bar on Friday night. - Vendors at Convention: BCBS, Dillards, GEHA, etc... may be there. Steve Luke's wife may be willing to set up items from her store at the Convention, sell them and then donate a percentage of the profits to IASCOE.

Membership Awards:
